27	BE IT FURTHER RESOLVED, that each employee of the Fifty-sixth Legislative		
28	Assembly is entitled to an additional \$1 per day for each previous regular session of the		
29	Legislative Assembly during which that employee was paid for at least 45 days, as either an		
30	employee of the Senate or the House, and to receive this additional compensation, which may		

1 not exceed \$10 per day, that employee must certify to the Legislative Council the year of each 2 regular session during which that employee was employed as required by this resolution; and 3 BE IT FURTHER RESOLVED, that each majority leader and each minority leader is 4 entitled to two staff assistants, but each majority or minority leader may hire fewer or more 5 assistants so long as the total daily compensation for the assistants hired does not exceed the 6 total daily amount authorized for those positions by this resolution; and 7 BE IT FURTHER RESOLVED, that the report of the Employment Committee of the 8 respective house identify the number of employees in each position by listing every employee 9 and the position for which employed; and 10 BE IT FURTHER RESOLVED, that with the approval of the Employment Committee of 11 the respective house, a position may be converted to a part-time position, with the daily 12 compensation converted to a per hour rate of pay; and 13 BE IT FURTHER RESOLVED, that if any employee resigns, is discharged, or for other 14 reasons terminates employment, the compensation provided by this resolution for that 15 employee ceases effective the last day of employment.
