AMENDMENT.** Section 54-54-04 of the North Dakota Century Code, is 19 amended and reenacted as follows: 20 54-54-04. Other employees - Appointment - Compensation. The chairman with the 21 approval of the council may employ such officers, experts, and other employees as may be 22 needed to carry out the provisions of this chapter. Such persons The executive director shall 23 serve at the pleasure of the chairman and the chairman shall fix their the compensation of the 24 executive director.
