## ENGROSSED SENATE BILL NO. 2010

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the council on the  
2 arts.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
5 funds as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the council on the arts for the purpose of defraying the expenses of the council  
8 on the arts, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

18 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**  
19 **SIXTY-SECOND LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time  
20 funding items approved by the sixtieth legislative assembly for the 2007-09 biennium and the  
21 2009-11 one-time funding items included in the appropriation in section 1 of this Act:

4 The 2009-11 one-time funding amounts are not a part of the entity's base budget for the  
5 2011-13 biennium. The council on the arts shall report to the appropriations committees of the  
6 sixty-second legislative assembly on the use of this one-time funding for the biennium  
7 beginning July 1, 2009, and ending June 30, 2011.

8 **SECTION 3. APPROPRIATION.** All income from the cultural endowment fund is  
9 appropriated to the council on the arts for the furthering of the cultural arts in the state for the  
10 biennium beginning July 1, 2009, and ending June 30, 2011.
