Engrossed HB 1501 with Senate Amendments imposes a gross receipts tax and an excise tax on marijuana and adult-use cannabis products.

Section 1 of engrossed HB 1501 with Senate Amendments imposes a fifteen percent gross receipts tax on the sale of usable marijuana and adult-use cannabis products. Twenty percent of this revenue must be transferred to the city or county in which the dispensary is located.

This section also imposes a ten percent excise tax on the sale from a manufacturer to a dispensary located in this state.

Engrossed HB 1501 with Senate Amendments, if enacted, is contingent upon the 67th Legislative Assembly passing HB 1420. It is not known if this will occur.
