Engrossed SB2238 relates to criminal history record checks for early childhood services providers.

Engrossed SB2238 requires the department to ensure fingerprinting is readily available for an individual. This is defined as the Department maintaining no fewer than twenty-one staffed finger printing stations and within forty-eight hours of an individual scheduling a request. In order for the Department to accomplish this, ten finger print scanners would need to be purchased and an additional ten FTE's would be needed to support each live scan machine.

The Department does not currently and does not plan to collect fees for background checks.

Engrossed SB2238 requires the Department to maintain no fewer than twenty-one staffed fingerprinting stations and within forty-eight hours of a request. The Department would need to purchase 10 scanners with a total cost of \$208,830, all of which is general fund, to make available across the state. In addition, the Department will need additional FTE to support the fingerprinting at each location. Ten FTE's with a total cost of \$1,330,328, all of which is general fund.
