



### Other Sections in Bill

Section 8 of this bill provides the statutory changes increasing the Attorney General's salary. The Attorney General's annual salary is increased from the current level of \$80,761 to \$83,991, effective July 1, 2007, and to \$87,351, effective July 1, 2008, to reflect the 4 percent and 4 percent recommended salary increase.

#### **Continuing Appropriations**

Asset forfeiture fund - NDCC Section 54-12-14 - To pay costs related to law enforcement activities of the Attorney General's office.

Lottery operating fund - NDCC Section 53-12.1-06 - To pay costs of operating the lottery.

Refund fund - NDCC Section 54-12-18 - To pay costs of the consumer protection and Antitrust Division and the Gaming Division.

Special operations team reimbursement fund - NDCC Section 54-12-23 - To reimburse city and county governments that provide special operations team services to rural areas.

#### **Major Related Legislation**

**Senate Bill No. 2097** - This bill increases the amount of fees the Attorney General may collect and deposit in the Attorney General's operating fund during the 2005-07 biennium for fire marshal services provided to entities covered by the fire and tornado fund and petroleum release compensation fund.

**Senate Bill No. 2103** - This bill appropriates \$500,000 from the insurance regulatory trust fund to the Attorney General for reimbursing health care providers for the cost of performing forensic medical examinations on victims of criminal sexual conduct.

Senate Bill No. 2260 - This bill expands the number of entities that may request criminal background checks on certain individuals.

**Senate Bill No. 2340** - This bill appropriates \$436,107 from the general fund to the Attorney General for the prosecution of civil commitment of sexually dangerous individuals.

**Senate Bill No. 2382** - This bill appropriates \$350,000 from the general fund and authorizes 2 FTE positions to the Attorney General for the Bureau of Criminal Investigation to conduct computer investigations and examinations.

**House Bill No. 1197** - This bill requires a DNA sample from each felony arrestee. The bill becomes effective when federal funds are available for the costs of implementing it.

**House Bill No. 1330** - This bill creates a multijurisdictional task force grant fund within the Attorney General's office from lottery revenue and provides a **continuing appropriation** to the Attorney General from money in the fund to be used for drug task forces throughout the state and for a .5 FTE position. The bill transfers \$125,000 per quarter from lottery revenues to this special fund.
