# **DEPARTMENT OF HEALTH AND HUMAN SERVICES**

The Department of Human Services (DHS) merged with the State Department of Health (DOH) in September 2022 to create the Department of Health and Human Services (DHHS) pursuant to the provisions of House Bill No. 1247 (2021). The Department of Human Services administers several programs that aid individuals. The department provides in-person services through eight regional human service centers, the State Hospital, and the Life Skills and Transition Center (LSTC).

The Department of Human Service's budget is divided into the following four budget areas:

### **MEDICAID PROGRAM**

The Medicaid program provides health coverage to qualifying individuals. During state fiscal year 2022, an estimated 90,390 North Dakotans received assistance through either the traditional Medicaid program, Medicaid Expansion program, or children's health insurance program.

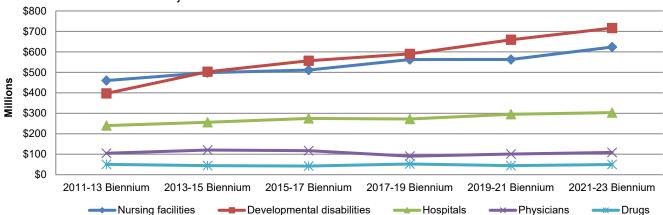
#### Federal Medical Assistance Percentage

The federal medical assistance percentage (FMAP) is the rate used to determine matching funds required by states for the Medicaid program. The federal medical assistance percentage is determined by comparing each state's 3-year average per capita income to the national 3-year average per capita income. The minimum FMAP a state may have is 50 percent. For federal fiscal year 2023 (October 2022 through September 2023), North Dakota's FMAP rate is 51.55 percent. Certain medical assistance programs, including the Medicaid Expansion program and children's health insurance program, use an enhanced FMAP rate which is 90 percent for the Medicaid Expansion program and 66.09 percent for the children's health insurance program for fiscal year 2023.

#### STATE HOSPITAL AND LIFE SKILLS AND TRANSITION CENTER

The Department of Human Services operates the State Hospital in Jamestown and LSTC in Grafton. The State Hospital provides inpatient mental health and addiction treatment services. The Life Skills and Transition Center provides residential and other services to individuals with an intellectual disability.

The schedule below details the average daily census of the State Hospital and LSTC.

#### **COUNTY SOCIAL AND HUMAN SERVICES PROJECT**

Senate Bill No. 2124 (2019) provides for the delivery of social services from human service zones rather than counties. The bill authorized the transfer of 140 employees from counties to DHS. The 2021 Legislative Assembly authorized 3 additional FTE positions to provide for a total of 143 FTE state employee positions for the county social and human services project during the 2021-23 biennium. During the November 2021 special legislative session, an additional 16 FTE positions for foster care licensing were transferred from human service center zones to state employment.

Senate Bill No. 2015 (2019) transferred \$173.7 million from the tax relief fund to the human service finance fund and Senate Bill No. 2012 (2019) appropriated the funds to DHS for payments to human service zones. The 2021 Legislative Assembly appropriated a total of \$189.9 million in funds, including \$187.2 million from the tax relief fund, \$1.5 million from the DHS operating fund, and \$1.2 million from the general fund to DHS for payments to human service zones during the 2021-23 biennium.
