## NORTH DAKOTA TAXABLE SALES AND PURCHASES QUARTERLY REPORT FOR THE QUARTER ENDING JUNE 30, 2018

This memorandum provides quarterly information regarding North Dakota taxable sales and purchases for the second quarter of the 2017 and 2018 calendar years. The amounts shown reflect taxable sales and purchases reported by the Tax Department for the respective reporting calendar year. Previous year amounts may differ from the previous reports due to classification changes, amendments, audit adjustments, or credits, which affect the previous year amounts.

The graph and schedule below provide information on the taxable sales and purchases for the second quarter of calendar years 2017 and 2018 for North Dakota in total, from consolidated and out-of-state reporting, and amounts reported for the 15 counties with the largest taxable sales and purchases. The consolidated category includes taxable sales and purchases from a limited number of permitholders that are not accurately attributable to a city or county. The consolidated data includes certain permitholders who have more than one permanent location or sales agent in North Dakota, but file a combined return. This primarily includes companies utilizing home-based, direct-sales employees. In addition, some industries are, by nature, not attributable to a specific city or county because their sales cover large geographical areas.
