ENGROSSED HOUSE BILL NO. 1038

1 A BILL for an Act to create and enact a new section to chapter 50-24.1 of the North Dakota
2 Century Code, relating to medical assistance coverage of prehospital emergency medical
3 services; to amend and reenact section 23-27-04.2 of the North Dakota Century Code, relating
4 to state assistance to prehospital emergency medical services; and to provide legislative intent
5 regarding state department of health assistance for ambulance medical assistance billings and
6 for appropriated funds.

7 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

8 **SECTION 1. AMENDMENT.** Section 23-27-04.2 of the 1997 Supplement to the North
9 Dakota Century Code is amended and reenacted as follows:

10 **23-27-04.2. Prehospital emergency medical services - State assistance.** The
11 ~~health services branch of the state department of health shall assist~~ offer services and financial
12 assistance in the training of personnel of certain prehospital emergency medical services as
13 determined by the ~~branch and financially shall assist certain prehospital emergency medical~~
14 ~~services as determined by the branch in obtaining equipment~~ department. Assistance No more
15 than one-half of the funds appropriated by the legislative assembly each biennium and
16 allocated for training assistance may be distributed in the first year of the biennium. Services
17 and financial assistance provided under this section must be within the limits of legislative
18 appropriation. The ~~health services branch~~ department shall adopt criteria for eligibility for
19 services and financial assistance in the training of personnel of various types of prehospital
20 emergency medical services. ~~To qualify for financial assistance for equipment, a prehospital~~
21 ~~emergency medical service shall certify, in the manner required by the health services branch,~~
22 ~~that the service has fifty percent of the amount of funds necessary for identified equipment~~
23 ~~acquisitions. The health services branch shall adopt a schedule of eligibility for financial~~
24 ~~assistance for equipment. The schedule must provide for a direct relationship between the~~

1 ~~amount of funds certified and the number of responses during the preceding calendar year for~~
2 ~~the purpose of rendering medical care, transportation, or both, to individuals who were sick or~~
3 ~~incapacitated. The schedule must require that as the number of responses increases, a~~
4 ~~greater amount of funds certified is required. The schedule must classify responses and the~~
5 ~~financial assistance available for various classifications. The health services branch~~
6 ~~department~~ may establish minimum and maximum amounts of financial assistance to be
7 provided a prehospital emergency medical service under this section. If applications for
8 financial assistance exceed the amount of allocated and available funds, the ~~health services~~
9 ~~branch~~ ~~department~~ may prorate the funds among the applicants in accordance with criteria
10 adopted by the ~~health services branch~~ ~~department~~. ~~No more than one-half of the funds~~
11 ~~appropriated by the legislative assembly each biennium and allocated for training assistance~~
12 ~~may be distributed in the first year of the biennium.~~

13 **SECTION 2.** A new section to chapter 50-24.1 of the North Dakota Century Code is
14 created and enacted as follows:

15 **Medical assistance - Prehospital emergency medical services.** Medical assistance
16 coverage provided by the department of human services must include coverage for prehospital
17 emergency medical services. This coverage must include provider reimbursement at a rate of
18 the lesser of one hundred percent of the amount billed or the rate established by the
19 department of human services reimbursement schedule for any prehospital emergency medical
20 services assessment commensurate with the level of training of the individual performing the
21 assessment. This coverage must include prehospital emergency medical services benefits in
22 the case of a medical condition that manifests itself by symptoms of sufficient severity which
23 may include severe pain and which a prudent layperson who possesses an average knowledge
24 of health and medicine could reasonably expect the absence of medical attention to result in
25 placing the person's health in jeopardy, serious impairment of a bodily function, or serious
26 dysfunction of any body part.

27 **SECTION 3. LEGISLATIVE INTENT - DEPARTMENT OF HEALTH - PILOT**
28 **PROJECT - AMBULANCE MEDICAL ASSISTANCE BILLINGS.** The state department of
29 health during the 1999-2001 biennium shall provide assistance with medical assistance billings
30 to six ambulance services on a pilot project basis at a cost of \$30,000 from funds, other than
31 emergency medical services funding, appropriated to the department in House Bill No. 1004.

1 **SECTION 4. INTENT.** The funds appropriated for the purpose of defraying expenses
2 of prehospital emergency medical services under sections 1 and 2 of this Act, for the biennium
3 beginning July 1, 1999, and ending June 30, 2001 include \$940,000 appropriated from the
4 general fund in 1999 House Bill No. 1004 for training for volunteers and a total of \$489,800, of
5 which \$146,880 is from the general fund appropriated in the medical assistance grants line item
6 in 1999 Senate Bill No. 2012 for reimbursement of prehospital emergency medical services.
7 The funds provided for training are for volunteer services based on \$2,200 for volunteer
8 ambulance service training, \$500 for volunteer rescue squad training, \$500 for the initial
9 training of volunteer emergency medical service providers, and \$1,500 for training of volunteer
10 quick response units, subject to reallocation by the state department of health based on training
11 applications and available funding.
