1 A BILL for an Act to amend and reenact section 11-11.1-01 of the North Dakota Century Code,
2 relating to elections to discontinue county job development authorities.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 11-11.1-01 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **11-11.1-01. Job development authority - Board of directors' members**
7 **qualifications.**

8 1. The board of county commissioners, by resolution, may create a job development
9 authority for the county, or may discontinue a job development authority which has
10 been created for the county.

11 a. If the authority is created, the question of discontinuing the authority may be
12 placed on the ballot at the next regular election by petition filed with the
13 county auditor at least ninety days before any countywide election and signed
14 by electors of the county who are residents of the area subject to taxation
15 under section 11-11.1-04 equal in number to ten percent of the votes cast in
16 the county in the area subject to taxation under section 11-11.1-04 for the
17 office of governor in the last general election.

18 b. The question to be voted on at the election must be submitted by ballot in
19 substantially the following form:

20 Should the (insert name of job development authority) Yes
21 be terminated? No

22 c. Only electors of the county who are residents of the area subject to taxation
23 under section 11-11.1-04 may vote on the question to discontinue the

- 1 authority. The question to discontinue the authority requires a majority of the
2 electors voting on the question for passage.
- 3 2. If the authority is created, a board of directors of not fewer than ten nor more than
4 twenty members must be appointed by the county commissioners and must consist
5 of representatives from the following groups, as they may exist:
- 6 ~~1.~~ a. Two members from the county commission.
- 7 ~~2.~~ b. One member from the city council or commission of each city within the
8 county which has a population of five hundred or more.
- 9 ~~3.~~ c. One member selected from among the city governments of the remaining
10 cities of the county.
- 11 ~~4.~~ d. If a majority of the townships in the county are organized townships, two
12 members selected from the township governments of the organized townships
13 in the county.
- 14 ~~5.~~ e. The remaining members must be selected from a list of candidates from the
15 following fields:
- 16 ~~a.~~ (1) A representative of the local job service office nearest the county seat.
- 17 ~~b.~~ (2) A member of the local airport authority.
- 18 ~~c.~~ (3) A member of a local institution of higher education.
- 19 ~~d.~~ (4) A member from among the school boards of the county.
- 20 ~~e.~~ (5) A member from a local industrial development organization.
- 21 ~~f.~~ (6) A member of the regional planning council serving the county.
- 22 ~~g.~~ (7) A member of the legislative assembly representing a district within the
23 county.
- 24 ~~h.~~ (8) Members at large from the county.
- 25 3. The county commissioners shall make ~~these~~ appointments to the board from a
26 slate of candidates submitted by the chambers of commerce within the county. If
27 no chamber of commerce exists in the county, the nominations may be submitted
28 by any civic or patriotic organization within the county. If names submitted are
29 unacceptable, the county commission may request additional nominees. The
30 members must be appointed without regard to political affiliation and upon their
31 fitness to serve as members by reason of character, experience, and training. All
