1 A BILL for an Act to amend and reenact subsection 15 of section 65-05-12.2 of the North
2 Dakota Century Code, relating to workers' compensation permanent impairment awards.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Subsection 15 of section 65-05-12.2 of the North Dakota
5 Century Code is amended and reenacted as follows:

6 15. If the injury causes permanent impairment, the percentage the impairment bears to
7 total impairment must be determined in accordance with the first applicable whole
8 body impairment schedule:
