

**HOUSE BILL NO. 1016**

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 corrections and rehabilitation.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the  
5 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in  
6 the state treasury, not otherwise appropriated, and from special funds derived from federal  
7 funds and other income, to the department of corrections and rehabilitation for the purpose of  
8 defraying the expenses of its various divisions, for the biennium beginning July 1, 1999, and  
9 ending June 30, 2001, as follows:

18           **SECTION 2. TRANSFER AUTHORITY - BUDGET SECTION APPROVAL.** Upon  
19 approval of the budget section, the director of the department of corrections and rehabilitation  
20 may transfer appropriation authority contained in the various subdivisions in section 1 of this  
21 Act.

22           **SECTION 3. LINE ITEM TRANSFERS - EMERGENCY COMMISSION AND BUDGET**  
23 **SECTION APPROVAL.** Upon approval of the emergency commission, the director of the  
24 department of corrections and rehabilitation may transfer between the victim services,  
25 institutional offender services, and community offender services line items in subdivision 3 of  
26 section 1 of this Act appropriation authority of up to ten percent of a given line item to adjust for  
27 changing circumstances in meeting established performance measures. Any further transfers  
28 must be approved by the budget section.
