## ENGROSSED SENATE BILL NO. 2291

1 A BILL for an Act to amend and reenact section 54-44.3-20 of the North Dakota Century Code,  
2 relating to exemption of the teaching staff of institutions of higher education from the state  
3 classified service.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 54-44.3-20 of the 1997 Supplement to the North  
6 Dakota Century Code is amended and reenacted as follows:

7 **54-44.3-20. Categories of positions in the state service.** All positions in the state  
8 service are included in the classified service except:

- 9 1. Each official elected by popular vote and each person appointed to fill vacancies in  
10 an elective office, one principal assistant, and one private secretary.
- 11 2. Members of boards and commissions required by law.
- 12 3. Administrative heads of departments required by law, other than the  
13 superintendent of the school for the blind, the superintendent of the school for the  
14 deaf, and the state librarian.
- 15 4. Officers and employees of the legislative branch of government.
- 16 5. Members of the judicial branch of government of the state of North Dakota and  
17 their employees and jurors.
- 18 6. Persons temporarily employed in a professional or scientific capacity as  
19 consultants or to conduct a temporary and special inquiry, investigation, or  
20 examination for the legislative branch of government or a department of the state  
21 government.

2                   nature of the position as determined by the division and approved by the board.
