- 1 A BILL for an Act to amend and reenact section 54-34.3-03 of the North Dakota Century Code,
- 2 relating to the structure of the department of economic development and finance; and to provide
- 3 for spending authority for the Bank of North Dakota and the department of economic
- 4 development and finance.

## BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1. AMENDMENT.** Section 54-34.3-03 of the 1999 Supplement to the North
- 7 Dakota Century Code is amended and reenacted as follows:
- 8 **54-34.3-03. Department structure.** The department consists of:
- 9 1. A division of finance; and
- 10 2. A marketing division, which may provide services for the entire department;
- 11 3. An economic development and finance service provider division, which may
  12 encompass services provided by more than one division of the department; and
- Other divisions that the director organizes and establishes as necessary to carry out most efficiently and effectively the mission and duties of the department.
- 15 **SECTION 2. SPENDING AUTHORITY.** The costs of administering the Bank of North
- 16 Dakota must be funded by profits of the Bank of North Dakota in an amount equal to at least
- 17 twenty-one percent of the Bank's profits. For purposes of administration of the Bank, the Bank
- 18 may not spend, and the industrial commission may not authorize the expenditure of, funds
- 19 appropriated or derived from any funding source other than the profits of the Bank of North
- 20 Dakota. Notwithstanding any provision of an Act providing an appropriation from any funding
- 21 source other than funds appropriated from the profits of the Bank of North Dakota for the
- 22 purpose of funding the administration of the Bank of North Dakota, the appropriated funds must
- 23 revert to the originating fund unless this section has been expressly suspended or repealed by

- 1 that bill or this section is expressly amended by that Act to authorize use of funds other than the
- 2 profits of the Bank of North Dakota.
- 3 **SECTION 3. SPENDING AUTHORITY.** The department of economic development and
- 4 finance may not spend funds appropriated from any funding other than the profits of the Bank of
- 5 North Dakota. Notwithstanding any provision of an Act providing an appropriation from any
- 6 funding source other than funds appropriated from the profits of the Bank of North Dakota for
- 7 the purpose of supporting the department of economic development and finance, the
- 8 appropriated funds must revert to the originating fund unless this section has been expressly
- 9 suspended or repealed or this section is expressly amended by that Act to authorize use of
- 10 funds other than the profits of the Bank of North Dakota.
