**SB 2396:** A BILL for an Act to amend and reenact section 26.1-36-24 of the North Dakota Century Code, relating to the transferability of health insurance policies. Was read the first time and referred to the **Industry, Business and Labor Committee.** 

**SB 2398:** A BILL for an Act to amend and reenact subsection 2 of section 4-09-03 of the North Dakota Century Code, relating to the state seed commission membership. Was read the first time and referred to the **Agriculture Committee.** 

**SB 2400:** A BILL for an Act to create and enact four new subsections to section 26.1-04-03, two new subsections to section 26.1-26.4-02, and four new sections to chapter 26.1-36 of the North Dakota Century Code, relating to fairness in health insurance practices, disclosure of health plan information, confidentiality of medical information maintained by health carriers, contract limitations, and health care grievance procedures; and to amend and reenact subsection 14 of section 26.1-04-03, subsection 9 of section 26.1-26.4-04, and section 26.1-47-02 of the North Dakota Century Code, relating to prohibited health insurance practices, health care utilization review procedures, and preferred provider arrangements.

Was read the first time and referred to the **Human Services Committee**.

**SB 2403:** A BILL for an Act to amend and reenact section 39-16-03.1 of the North Dakota Century Code, relating to the confidentiality of a driver record or abstract. Was read the first time and referred to the **Transportation Committee.** 

**SB 2404:** A BILL for an Act to create and enact a new section to chapter 52-08 of the North Dakota Century Code, relating to work force training; and to provide an appropriation. Was read the first time and referred to the **Education Committee.** 

**SB 2405:** A BILL for an Act to amend and reenact sections 5-02-01.1 and 5-02-06 of the North Dakota Century Code, relating to the sale of alcoholic beverages; and to declare an emergency.

Was read the first time and referred to the Political Subdivisions Committee.

SB 2407: A BILL for an Act to create and enact a new section to chapter 26.1-26 of the North Dakota Century Code, relating to insurance sales by rental car agencies.Was read the first time and referred to the Industry, Business and Labor Committee.

**SB 2409:** A BILL for an Act to amend and reenact section 32-23-11 of the North Dakota Century Code, relating to parties in a declaratory action.

Was read the first time and referred to the **Judiciary Committee**.

**SB 2410:** A BILL for an Act to create and enact a new section to chapter 15-47 of the North Dakota Century Code, relating to an early childhood education certificate. Was read the first time and referred to the **Education Committee.** 

**SB 2411:** A BILL for an Act to amend and reenact section 54-46.1-01 of the North Dakota Century Code, relating to the provision of microfilm services; and to declare an emergency.

Was read the first time and referred to the Government and Veterans Affairs Committee.

**SB 2413:** A BILL for an Act to create and enact a new chapter to title 14 of the North Dakota Century Code, relating to a North Dakota human rights commission; to amend and reenact sections 14-02.4-19 and 14-02.4-21 of the North Dakota Century Code, relating to actions, limitations, and mediation for discriminatory practices; and to provide a penalty.

Was read the first time and referred to the **Appropriations Committee**.

**SB 2414:** A BILL for an Act to create a North Dakota higher education savings plan; and to provide an appropriation.

Was read the first time and referred to the Education Committee.

**SB 2419:** A BILL for an Act to create and enact a new section to chapter 54-12 of the North Dakota Century Code, relating to funds recovered by the attorney general; and to amend and reenact section 54-12-18 of the North Dakota Century Code, relating to the attorney general refund fund.

Was read the first time and referred to the Finance and Taxation Committee.

**SB 2421:** A BILL for an Act to amend and reenact subdivision e of subsection 5 of section 57-39.2-04.3 of the North Dakota Century Code, relating to a sales tax exemption for certain machinery and equipment for refining of crude oil; to provide an effective date; and to provide an expiration date.

Was read the first time and referred to the Finance and Taxation Committee.

**SB 2425:** A BILL for an Act to create and enact a new chapter to title 4 of the North Dakota Century Code, relating to the establishment of a livestock production loan program and the issuance of revenue bonds or other evidences of indebtedness by the industrial commission of North Dakota.

Was read the first time and referred to the Agriculture Committee.

**SB 2426:** A BILL for an Act to provide that the operation of sport shooting ranges may not be deemed a nuisance; to provide an effective date; and to declare an emergency.

Was read the first time and referred to the Natural Resources Committee.

**SB 2434:** A BILL for an Act to amend and reenact section 24-17-03 of the North Dakota Century Code, relating to outdoor advertising.

Was read the first time and referred to the **Transportation Committee**.

**SB 2435:** A BILL for an Act to provide an exemption from motor vehicle operator's license provisions for train crew members.

Was read the first time and referred to the **Transportation Committee**.

**SB 2436:** A BILL for an Act to amend and reenact section 54-35-01 of the North Dakota Century Code, relating to the composition of the North Dakota legislative council; and to provide an effective date.

Was read the first time and referred to the Government and Veterans Affairs Committee.

**SB 2437:** A BILL for an Act to create and enact a new section to chapter 23-15 of the North Dakota Century Code, relating to fireworks sales for New Year's Eve 2000; and to amend and reenact section 23-15-01 of the North Dakota Century Code, relating to the sale of fireworks.

Was read the first time and referred to the Industry, Business and Labor Committee.

**SB 2438:** A BILL for an Act to amend and reenact section 39-32-02 of the North Dakota Century Code, relating to interstate exemptions from federal hours of service provisions. Was read the first time and referred to the **Transportation Committee.**
