1 A BILL for an Act to create and enact a new section to chapter 25-17 of the North Dakota
2 Century Code, relating to definitions for the newborn screening law; and to amend and reenact
3 sections 25-17-01, 25-17-02, 25-17-03, 25-17-04, 25-17-05, and 26.1-36-09.7 of the North
4 Dakota Century Code, relating to services and insurance coverage for treatment of metabolic
5 diseases.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1.** A new section to chapter 25-17 of the North Dakota Century Code is
8 created and enacted as follows:

9 **Definitions.** As used in this chapter, unless the context otherwise requires:

- 10 1. "Low-protein modified food product" means a food product that is specially
11 formulated to have less than one gram of protein per serving and is intended to be
12 used under the direction of a physician for the dietary treatment of a metabolic
13 disease. The term does not include a natural food that is naturally low in protein.
14 2. "Medical food" means a food that is intended for the dietary treatment of a disease
15 or condition for which nutritional requirements are established by medical
16 evaluation and is formulated to be consumed or administered under the direction
17 of a physician.
18 3. "Metabolic disease" means a disease as designated by rule of the state health
19 council for which early identification and timely intervention will lead to a significant
20 reduction in mortality, morbidity, and associated disabilities.

21 **SECTION 2. AMENDMENT.** Section 25-17-01 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **25-17-01. ~~Phenylketonuria and galactosemia~~ Newborn screening education**
24 **programs and tests.** The state department of health shall:

- 1 1. Develop and ~~carry out an intensive~~ implement a metabolic disease educational
2 program among physicians, hospital ~~staffs of hospitals~~, public health nurses, and
3 the citizens of this state ~~concerning the diseases phenylketonuria and~~
4 ~~galactosemia, and other metabolic diseases causing mental retardation for which~~
5 ~~appropriate methods of detection, prevention, or treatment are available.~~ This
6 educational program must include information about the nature of the diseases
7 and ~~examinations~~ about screening for the early detection of ~~such~~ these diseases
8 ~~in order so~~ that proper measures may be taken to ~~prevent mental retardation~~
9 reduce mortality, morbidity, and associated disabilities.
- 10 2. Provide, on a statewide basis, a newborn screening, diagnostic, system and
11 ~~treatment control tests~~ short-term followup services for which ~~approved laboratory~~
12 ~~procedures are available for phenylketonuria, galactosemia, and other metabolic~~
13 ~~diseases causing mental retardation.~~
- 14 3. Provide that, ~~upon completion of the testing, the actual testing materials must be~~
15 ~~returned to the department. The department shall forward the actual testing~~
16 ~~materials to the university of North Dakota school of medicine for storage and~~
17 ~~research purposes. The materials in the possession of the university of North~~
18 ~~Dakota school of medicine may not be destroyed without the authorization of the~~
19 ~~department. Coordinate with or refer individuals to public and private health care~~
20 ~~service providers for long-term followup services for metabolic diseases.~~

21 **SECTION 3. AMENDMENT.** Section 25-17-02 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **25-17-02. Establishment of testing regulations Rulemaking requirement.** The
24 state department of health council shall ~~establish standards and methods of testing to be~~
25 ~~employed for the determination of the diseases referred to in section 25-17-01 for which~~
26 ~~statewide testing programs are established~~ adopt rules necessary to implement this chapter.

27 **SECTION 4. AMENDMENT.** Section 25-17-03 of the North Dakota Century Code is
28 amended and reenacted as follows:

29 **25-17-03. Treatment for positive diagnosis - Registry of cases.** The state
30 department of health shall:

- 1 1. Follow up ~~all~~ with attending physicians cases with positive tests for
2 ~~phenylketonuria, galactosemia, and other~~ metabolic diseases ~~with the attending~~
3 ~~physician~~ in order to determine the exact diagnosis.
- 4 2. ~~Make arrangements~~ Refer every diagnosed case of a metabolic disease to a
5 qualified health care provider for the necessary treatment for diagnosed cases
6 ~~where treatment is indicated and the family is unable to pay the cost of such~~
7 ~~treatment~~ of the metabolic disease.
- 8 3. Provide medical food at no cost to males under age twenty-two and females under
9 age forty-five who are diagnosed with phenylketonuria or maple syrup urine
10 disease, regardless of income.
- 11 4. Offer for sale at cost medical food to females age forty-five and over and to males
12 age twenty-two and over who are diagnosed with phenylketonuria or maple syrup
13 urine disease, regardless of income. These individuals are responsible for
14 payment to the department for the cost of the medical food.
- 15 5. Deposit any money collected under subsection 4 in the department's operating
16 account for the purpose of defraying the expenses of providing treatment services
17 under this section.
- 18 6. Provide low-protein modified food products, if medically necessary as determined
19 by a qualified health care provider, to females under age forty-five and males
20 under age twenty-two who are receiving medical assistance and are diagnosed
21 with phenylketonuria or maple syrup urine disease.
- 22 7. ~~Maintain a registry of cases of phenylketonuria, galactosemia, and other metabolic~~
23 ~~diseases for the purpose of followup services to prevent mental retardation.~~

24 **SECTION 5. AMENDMENT.** Section 25-17-04 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **25-17-04. ~~Physician to initiate test and report positive diagnosis~~ Testing and**
27 **reporting requirements.** The physician attending a newborn child, or the birth attendant in the
28 case of an out-of-hospital birth, shall cause that newborn child to be subjected to testing for
29 ~~phenylketonuria, galactosemia, and other~~ metabolic diseases, in the manner prescribed by the
30 state department of health. A physician attending a ~~case of phenylketonuria, galactosemia, or~~
31 ~~other~~ patient with a metabolic disease ~~which may cause mental retardation~~ shall report the

1 case to the state department of health. ~~This~~ The testing requirements of this section does do
2 not apply if the parents of a newborn child object ~~thereto~~ to the testing on the grounds that
3 testing for metabolic diseases conflicts with their religious tenets and practices.

4 **SECTION 6. AMENDMENT.** Section 25-17-05 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **25-17-05. Testing charges.** The state ~~department of health shall~~ council may adopt
7 rules that establish reasonable fees and may impose those fees to cover the costs of
8 administering tests under this chapter. All test fees collected by the state department of health
9 must be deposited in the state department of health operating account.

10 **SECTION 7. AMENDMENT.** Section 26.1-36-09.7 of the 1999 Supplement to the
11 North Dakota Century Code is amended and reenacted as follows:

12 **26.1-36-09.7. Foods and food products for inherited metabolic diseases.**

13 1. As used in this section:

- 14 a. "Inherited metabolic disease" means maple syrup urine disease or
15 phenylketonuria.
- 16 b. "Low-protein modified food product" means a food product that is specially
17 formulated to have less than one gram of protein per serving and is intended
18 to be used under the direction of a physician for the dietary treatment of an
19 inherited metabolic disease. The term does not include a natural food that is
20 naturally low in protein.
- 21 c. "Medical food" means a food that is intended for the dietary treatment of a
22 disease or condition for which nutritional requirements are established by
23 medical evaluation and is formulated to be consumed or administered under
24 the direction of a physician.

25 2. An insurance company, nonprofit health service corporation, or health
26 maintenance organization may not deliver, issue, execute, or renew any health
27 insurance policy, health service contract, or evidence of coverage that provides
28 prescription coverage on an individual, group, blanket, franchise, or association
29 basis, unless the policy or contract provides, for any person covered under the
30 policy or contract, coverage for medical foods and low-protein modified food

- 1 products determined by a physician to be medically necessary for the therapeutic
2 treatment of an inherited metabolic disease.
- 3 3. This section applies to any covered individual born after December 31, 1962. This
4 section does not require coverage ~~for low-protein modified food products~~ in excess
5 of three thousand dollars per year total for low-protein modified food products or
6 medical food for an individual with an inherited metabolic disease of amino acid or
7 organic acid.
- 8 4. This section does not require medical benefits coverage for low protein modified
9 food products or medical food for an individual to the extent those benefits are
10 available to that individual under a department of health program.
