ENGROSSED HOUSE BILL NO. 1443

1 A BILL for an Act to amend and reenact subsection 8 of section 39-06.1-06, paragraph 34 of
2 subdivision a of subsection 3 of section 39-06.1-10, and subsection 1 of section 39-09-02 of the
3 North Dakota Century Code, relating to speed limit fees and demerit points.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 8 of section 39-06.1-06 of the 1999
6 Supplement to the North Dakota Century Code is amended and reenacted as follows:

7 8. On a highway on which the speed limit is a speed higher than fifty-five miles [88.51
8 kilometers] an hour, for a violation of section 39-09-02, or an equivalent ordinance,
9 a fee established as follows:

Miles per hour over	Fee
lawful speed limit	
1 - 5	\$ 10 plus \$1/each mph over limit
6 - 10	\$ 15 plus \$2/each mph over 5 mph over limit
11 - 15	\$ 25 plus \$3/each mph over 10 mph over limit
16 - 25	\$ 40 <u>80</u> plus \$3/each mph over 15 mph over limit
26 - 35	\$ 70 <u>140</u> plus \$3/each mph over 25 mph over limit
36 +	\$ 400 <u>200</u> plus \$5/each mph over 35 mph over limit

18 **SECTION 2. AMENDMENT.** Paragraph 34 of subdivision a of subsection 3 of section
19 39-06.1-10 of the 1999 Supplement to the North Dakota Century Code is amended and
20 reenacted as follows:

21 (34) On a highway on which the

14 **SECTION 3. AMENDMENT.** Subsection 1 of section 39-09-02 of the North Dakota

15 Century Code is amended and reenacted as follows:

- 16 1. Subject to the provisions of section 39-09-01 and except in those instances where
17 a lower speed is specified in this chapter, it presumably is lawful for the driver of a
18 vehicle to drive the same at a speed not exceeding:
- 19 a. Twenty miles [32.19 kilometers] an hour when approaching within fifty feet
20 [15.24 meters] of a grade crossing of any steam, electric, or street railway
21 when the driver's view is obstructed. A driver's view is deemed to be
22 obstructed when at any time during the last two hundred feet [60.96 meters]
23 of the driver's approach to such crossing, the driver does not have a clear and
24 uninterrupted view of such railway crossing and of any traffic on such railway
25 for a distance of four hundred feet [121.92 meters] in each direction from such
26 crossing.
- 27 b. Twenty miles [32.19 kilometers] an hour when passing a school during school
28 recess or while children are going to or leaving school during opening or
29 closing hours.
- 30 c. Twenty miles [32.19 kilometers] an hour when approaching within fifty feet
31 [15.24 meters] and in traversing an intersection of highways when the driver's

- 1 view is obstructed. A driver's view is deemed to be obstructed when at any
2 time during the last fifty feet [15.24 meters] of the driver's approach to such
3 intersection, the driver does not have a clear and uninterrupted view of such
4 intersection and of the traffic upon all of the highways entering such
5 intersection for a distance of two hundred feet [60.96 meters] from such
6 intersection.
- 7 d. Twenty miles [32.19 kilometers] an hour when the driver's view of the highway
8 ahead is obstructed within a distance of one hundred feet [30.48 meters].
- 9 e. Twenty-five miles [40.23 kilometers] an hour on any highway in a business
10 district or in a residence district or in a public park, unless a different speed is
11 designated and posted by local authorities.
- 12 f. Fifty-five miles [88.51 kilometers] an hour on gravel, dirt, or loose surface
13 highways, and on paved two-lane highways if there is no speed limit posted
14 or if within the time period of one-half hour after sunset to one-half hour
15 before sunrise, unless otherwise permitted, restricted, or required by
16 conditions.
- 17 g. Sixty-five miles [104.61 kilometers] an hour on paved two-lane highways if
18 within the time period of one-half hour before sunrise to one-half hour after
19 sunset and if posted for that speed, and on paved and divided multilane
20 highways, unless otherwise permitted, restricted, or required by conditions.
- 21 h. ~~Seventy~~ Seventy-five miles [112.65 kilometers] an hour on access-controlled,
22 paved and divided, multilane interstate highways, unless otherwise permitted,
23 restricted, or required by conditions.
