1 A BILL for an Act to create and enact a new subsection to section 20.1-03-12 of the North
2 Dakota Century Code, relating to nonresident hunting fees; to amend and reenact subsection 1
3 of section 20.1-03-07, section 20.1-03-07.1, and subsections 2, 7, 8, 37, 38, and 39 of section
4 20.1-03-12 of the North Dakota Century Code, relating to nonresident hunting and fishing
5 licenses and fees; to provide an effective date; and to declare an emergency.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Subsection 1 of section 20.1-03-07 of the 1999

8 Supplement to the North Dakota Century Code is amended and reenacted as follows:

9 1. Hunt, catch, take, or kill any small game without a nonresident small game license.
10 The nonresident small game license entitles the nonresident to hunt small game
11 for any period of fourteen consecutive days or any two periods of seven
12 consecutive days each. The hunting period for which the license is valid must be
13 designated on the license. A nonresident small game license is not required to
14 hunt waterfowl under section 20.1-03-07.1. A nonresident may purchase more
15 than one nonresident small game license per year.

16 **SECTION 2. AMENDMENT.** Section 20.1-03-07.1 of the 1999 Supplement to the
17 North Dakota Century Code is amended and reenacted as follows:

18 **20.1-03-07.1. Nonresident waterfowl hunting license required.** Except as provided
19 in sections 20.1-03-07.2 and 20.1-03-07.3, a nonresident may not hunt waterfowl unless that
20 person first obtains a nonresident waterfowl hunting license, ~~in addition to a nonresident small~~
21 ~~game hunting license.~~ The nonresident waterfowl hunting license entitles the nonresident to
22 hunt waterfowl for any period of fourteen consecutive days, any period of seven consecutive
23 days, or any two periods of seven consecutive days each. A license authorizing the
24 fourteen-day hunting period allows hunting in a specified waterfowl hunting zone. A license

1 authorizing one 7-day hunting period allows hunting statewide. A license authorizing two 7-day
2 hunting periods allows hunting in a specified zone during each period. A combination
3 nonresident waterfowl and nonresident small game hunting license allows hunting of waterfowl
4 for either the fourteen-day period, seven-day period, or two 7-day periods as provided in this
5 section as well as upland game as provided in subsection 1 of section 20.1-03-07. The
6 governor, in the governor's proclamation, shall specify various waterfowl hunting zones for
7 which nonresident waterfowl hunting licenses will be available, and may specify the number of
8 licenses which may be issued in each zone and the manner in which they are to be issued. A
9 nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.

10 **SECTION 3. AMENDMENT.** Subsections 2 and 37 of section 20.1-03-12 of the 1999
11 Supplement to the North Dakota Century Code are amended and reenacted as follows:

12 2. For a nonresident small game hunting license, ~~seventy five~~ eighty-five dollars.

13 37. For a nonresident waterfowl hunting license, ~~ten~~ eighty-five dollars.

14 **SECTION 4. AMENDMENT.** Subsections 7, 8, 38, and 39 of section 20.1-03-12 of the
15 1999 Supplement to the North Dakota Century Code are amended and reenacted as follows:

16 7. For a nonresident fishing license, ~~twenty five~~ thirty-two dollars.

17 8. For a nonresident short-term seven-day fishing license, ~~fifteen~~ twenty dollars.

18 38. For a nonresident husband and wife fishing license, ~~thirty five~~ forty-five dollars.

19 39. For a nonresident short-term three-day fishing license, ~~ten~~ fifteen dollars.

20 **SECTION 5.** A new subsection to section 20.1-03-12 of the 1999 Supplement to the
21 North Dakota Century Code is created and enacted as follows:

22 For a combination nonresident waterfowl and nonresident small game hunting
23 license, one hundred thirty dollars.

24 **SECTION 6. EFFECTIVE DATE.** Section 4 of this Act becomes effective on April 1,
25 2002.

26 **SECTION 7. EMERGENCY.** Sections 1, 2, 3, and 5 of this Act are declared to be an
27 emergency measure.
