

**FIRST ENGROSSMENT
with Conference Committee Amendments**

ENGROSSED HOUSE BILL NO. 1468

1 A BILL for an Act to create and enact two new subsections to section 20.1-03-12 of the North
2 Dakota Century Code, relating to nonresident hunting fees; to amend and reenact subsection 1
3 of section 20.1-03-07, section 20.1-03-07.1, and subsections 2, 7, 8, 37, 38, and 39 of section
4 20.1-03-12 of the North Dakota Century Code, relating to nonresident hunting and fishing
5 licenses and fees; and to provide an effective date.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. AMENDMENT.** Subsection 1 of section 20.1-03-07 of the 1999
8 Supplement to the North Dakota Century Code is amended and reenacted as follows:

9 1. Hunt, catch, take, or kill any small game without a nonresident small game license.
10 The nonresident small game license entitles the nonresident to hunt small game
11 for any period of fifteen consecutive days or any three periods of five consecutive
12 days each. The nonresident all season small game license entitles the
13 nonresident to hunt small game for the entire season. The hunting period for
14 which the license is valid must be designated on the license. A nonresident small
15 game license is not required to hunt waterfowl under section 20.1-03-07.1. A
16 nonresident may purchase more than one nonresident small game license per
17 year.

18 **SECTION 2. AMENDMENT.** Section 20.1-03-07.1 of the 1999 Supplement to the
19 North Dakota Century Code is amended and reenacted as follows:

20 **20.1-03-07.1. Nonresident waterfowl hunting license required.** Except as provided
21 in sections 20.1-03-07.2 and 20.1-03-07.3, a nonresident may not hunt waterfowl unless that
22 person first obtains a nonresident waterfowl hunting license, ~~in addition to a nonresident small~~
23 ~~game hunting license.~~ The nonresident waterfowl hunting license entitles the nonresident to
24 hunt waterfowl for any period of fourteen consecutive days, any period of seven consecutive

1 days, or any two periods of seven consecutive days each. A license authorizing the
2 fourteen-day hunting period allows hunting in a specified waterfowl hunting zone. A license
3 authorizing one 7-day hunting period allows hunting statewide. A license authorizing two 7-day
4 hunting periods allows hunting in a specified zone during each period. A combination
5 nonresident waterfowl and nonresident small game hunting license allows hunting of waterfowl
6 for either the fourteen-day period, seven-day period, or two 7-day periods as provided in this
7 section as well as upland game as provided in subsection 1 of section 20.1-03-07. The
8 governor, in the governor's proclamation, shall specify various waterfowl hunting zones for
9 which nonresident waterfowl hunting licenses will be available, and may specify the number of
10 licenses which may be issued in each zone and the manner in which they are to be issued. A
11 nonresident is entitled to purchase only one nonresident waterfowl hunting license per year.

12 **SECTION 3. AMENDMENT.** Subsections 2 and 37 of section 20.1-03-12 of the 1999
13 Supplement to the North Dakota Century Code are amended and reenacted as follows:

- 14 2. For a nonresident small game hunting license, ~~seventy-five~~ eighty-five dollars.
15 37. For a nonresident waterfowl hunting license, ~~ten~~ eighty-five dollars.

16 **SECTION 4. AMENDMENT.** Subsections 7, 8, 38, and 39 of section 20.1-03-12 of the
17 1999 Supplement to the North Dakota Century Code are amended and reenacted as follows:

- 18 7. For a nonresident fishing license, ~~twenty-five~~ thirty-two dollars.
19 8. For a nonresident short-term seven-day fishing license, ~~fifteen~~ twenty dollars.
20 38. For a nonresident husband and wife fishing license, ~~thirty-five~~ forty-five dollars.
21 39. For a nonresident short-term three-day fishing license, ~~ten~~ fifteen dollars.

22 **SECTION 5.** Two new subsections to section 20.1-03-12 of the 1999 Supplement to
23 the North Dakota Century Code are created and enacted as follows:

24 For a combination nonresident waterfowl and nonresident small game hunting
25 license, one hundred thirty dollars.

26 For a nonresident all season small game hunting license, two hundred fifty dollars.

27 **SECTION 6. EFFECTIVE DATE.** Section 4 of this Act becomes effective on April 1,
28 2002.
