

**FIRST ENGROSSMENT
with House Amendments**

ENGROSSED SENATE BILL NO. 2013

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the commissioner of
2 university and school lands.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
5 funds as may be necessary, are appropriated from special funds derived from the state lands
6 maintenance fund and the oil and gas impact grant fund in the state treasury, not otherwise
7 appropriated, to the commissioner of university and school lands for the purpose of defraying
8 the expenses of the commissioner of university and school lands, for the biennium beginning
9 July 1, 2001, and ending June 30, 2003, as follows:

10	Salaries and wages	\$1,836,257
11	Operating expenses	736,457
12	Equipment	48,050
13	Grants	<u>4,888,100</u>
14	Total special funds	\$7,508,864

15 **SECTION 2. OIL AND GAS IMPACT GRANT FUND.** The amount of \$5,000,000, or
16 so much of the amount as may be necessary, included in the total special funds appropriated in
17 section 1 of this Act may be spent from the oil and gas impact grant fund by the commissioner
18 of university and school lands for the purpose of providing oil and gas development impact
19 grants and the administration of the oil and gas development impact grant program for the
20 biennium beginning July 1, 2001, and ending June 30, 2003.

21 **SECTION 3. GRANTS.** Section 54-44.1-11 does not apply to appropriations made for
22 oil impact grants in section 1 of this Act.

23 **SECTION 4. DISTRIBUTIONS TO STATE INSTITUTIONS.** Notwithstanding section
24 15-03-05.2, during the biennium beginning July 1, 2001, and ending June 30, 2003, the board
