

**SENATE BILL NO. 2023**

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for capital projects of various state departments  
2 and institutions; to provide an appropriation for state facility energy improvement capital  
3 projects of various state departments and institutions; to authorize the industrial commission to  
4 issue and sell bonds for capital projects; to provide an appropriation; and to declare an  
5 emergency.

6 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

7 **SECTION 1. PROJECT AUTHORIZATIONS.** The industrial commission, acting as the  
8 North Dakota building authority, shall arrange for the funding of the projects authorized in this  
9 section, hereby declared to be in the public interest, through the issuance of evidences of  
10 indebtedness under chapter 54-17.2, during the biennium beginning July 1, 2001, and ending  
11 June 30, 2003. The proceeds of the evidences of indebtedness and other available funds are  
12 hereby appropriated during the biennium beginning July 1, 2001, and ending June 30, 2003, for  
13 the following projects:

14 State department of health	Laboratory addition	\$2,700,000
15 Minot state university	Old main renovation	5,076,000
16 Job service North Dakota	Bismarck service delivery office	2,302,000

17 The industrial commission shall issue evidences of indebtedness under this section with  
18 the condition that lease rental payments need not begin until July 1, 2003. This authority of the  
19 industrial commission to issue evidences of indebtedness ends June 30, 2003, but the industrial  
20 commission may continue to exercise all other powers granted to it under chapter 54-17.2 and  
21 this Act and to comply with any covenants entered into before that date.

23 **SECTION 2. BOND ISSUANCE REPAYMENT RESPONSIBILITY.** Of the total amount  
24 of evidences of indebtedness issued under the provisions of section 1 of this Act, a total of

1 \$4,057,000 must be available from nongeneral fund sources to assist in the retirement of the  
2 evidences of indebtedness issued for the project costs associated with the construction of the  
3 projects authorized by this Act:

4 State department of health	\$1,755,000
5 Job service North Dakota	2,302,000

6 **SECTION 3. STATE FACILITY ENERGY IMPROVEMENT PROJECT**

7 **AUTHORIZATIONS.** The industrial commission, acting as the North Dakota building authority,  
8 shall arrange for the funding of the projects authorized in this section, which are described in  
9 the report filed by the division of community services of the office of management and budget  
10 with the governor, dated August 30, 2000, and which are hereby declared to be in the public  
11 interest, through the issuance of evidences of indebtedness under chapter 54-17.2 and section  
12 54-44.5-08, during the biennium beginning July 1, 2001, and ending June 30, 2003. The  
13 proceeds of the evidences of indebtedness and other available funds are hereby appropriated  
14 during the biennium beginning July 1, 2001, and ending June 30, 2003, for the following  
15 projects:

16 Department of transportation	Headquarters building	\$352,600
17 North Dakota state university	Sundry projects	296,348
18 University of North Dakota	Sundry projects	3,990,785

19 The authority of the industrial commission to issue evidences of indebtedness under this  
20 section ends June 30, 2003, but the industrial commission may continue to exercise all other  
21 powers granted to it under chapter 54-17.2, section 54-44.5-08, and this Act, and comply with  
22 any covenants entered into before that date.
