ENGROSSED HOUSE BILL NO. 1178

1 A BILL for an Act to amend and reenact subsections 2 and 3 of section 47-22-06.1,
2 subsection 5 of section 47-22-08, subsections 2 and 3 of section 47-25-06.1, and subsection 4
3 of section 47-25-07 of the North Dakota Century Code, relating to name changes of registrants
4 and cancellations of trademarks and trade names filed with the secretary of state.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** Subsections 2 and 3 of section 47-22-06.1 of the North
7 Dakota Century Code are amended and reenacted as follows:

8 2. A certificate of fact reciting the name change duly authenticated by the proper
9 officer of the state or country if the registrant is a corporation ~~or~~, limited liability
10 company, limited partnership, limited liability partnership, or limited liability limited
11 partnership incorporated or organized in another state or country and does not
12 have a certificate of authority to transact business in North Dakota.

13 3. An amendment or application for amended certificate of authority for a registrant
14 that is a corporation ~~or~~, limited liability company, limited partnership, limited liability
15 partnership, or limited liability limited partnership registered with the secretary of
16 state.

17 **SECTION 2. AMENDMENT.** Subsection 5 of section 47-22-08 of the North Dakota
18 Century Code is amended and reenacted as follows:

19 5. Any trademark whose registered owner is a corporation ~~or~~, limited liability
20 company, limited partnership, limited liability partnership, or limited liability limited
21 partnership that has ceased to exist for six months.

22 **SECTION 3. AMENDMENT.** Subsections 2 and 3 of section 47-25-06.1 of the North
23 Dakota Century Code are amended and reenacted as follows:

- 1 2. A certificate of fact reciting the name change duly authenticated by the proper
2 officer of the state or country if the registrant is a corporation ~~or~~, limited liability
3 company, limited partnership, limited liability partnership, or limited liability limited
4 partnership incorporated or organized in another state or country and does not
5 have a certificate of authority to transact business in North Dakota; or
6 3. An amendment or application for amended certificate of authority for a registrant
7 that is a corporation ~~or~~, limited liability company, limited partnership, limited liability
8 partnership, or limited liability limited partnership registered with the secretary of
9 state.

10 **SECTION 4. AMENDMENT.** Subsection 4 of section 47-25-07 of the North Dakota
11 Century Code is amended and reenacted as follows:

- 12 4. Any trade name when the registrant is a corporation, limited liability company,
13 limited partnership, limited liability partnership, or limited liability limited partnership
14 that has ceased to exist for six months.
