

SENATE BILL NO. 2106

Introduced by

(At the request of the Superintendent of Public Instruction)

1 A BILL for an Act to amend and reenact sections 15-40.3-01, 15-40.3-06, and 15-40.3-07 of the
2 North Dakota Century Code or in the alternative to amend and reenact sections 15.1-31-01,
3 15.1-31-06, and 15.1-31-07 of the North Dakota Century Code, relating to open enrollment
4 between school districts.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. AMENDMENT.** If House Bill No. 1045 does not become effective, section
7 15-40.3-01 of the 1999 Supplement to the North Dakota Century Code is amended and
8 reenacted as follows:

9 **15-40.3-01. Open enrollment - Procedure.** A student's parent or legal guardian who
10 wishes to enroll the student in a North Dakota school district other than the student's district of
11 residence shall, not later than February first of the school year preceding the year of enrollment,
12 apply to the school board of the student's district of residence, on forms provided by the
13 superintendent of public instruction, for approval to enroll the student in a district other than the
14 student's district of residence. By March first of the school year preceding the year of
15 enrollment, the school board of the district of residence shall act on the application, notify the
16 parent or legal guardian of the board's decision within five days, and if the application is
17 approved, immediately transmit the application to the admitting district. By April first, the board
18 of the admitting district shall approve or disapprove the application. The board of the admitting
19 district shall notify the board of the district of residence and the student's parent or legal
20 guardian within five days regarding its decision. Notice of intent to enroll in the admitting district
21 obligates the student to attend the admitting district during the following school year, unless the
22 school boards of the resident and the admitting districts agree in writing to allow the student to
23 transfer back to the resident district, or the student's parents or guardians change residence to
24 another district. All applications must be reviewed in the order that they are received. A

1 student whose school district of residence does not offer the grade level in which the student
2 requires enrollment may not participate in open enrollment. For purposes of determining
3 whether the grade level in which a student requires enrollment is offered, the several school
4 districts cooperating with each other for the joint provision of educational services under a plan
5 approved by the superintendent of public instruction must be considered to be a single district.
6 A child placed at a group or residential care facility or a residential treatment center in
7 accordance with section 15-40.2-08 is not eligible for open enrollment under this section. The
8 school board of a school district of residence and of an admitting district shall waive the
9 application, consideration, and approval dates in this section for any student who, together with
10 the student's parent or legal guardian, moves from the student's school district of residence to
11 another school district and who wishes to enroll in a school district, other than the district to
12 which the student moved. The school board of a school district of residence and of an
13 admitting district shall waive the application, consideration, and approval dates in this section
14 for any student who, together with the student's parent or legal guardian, moves into this state
15 from out of state and who wishes to enroll in a school district other than the district to which the
16 student moved.

17 **SECTION 2. AMENDMENT.** If House Bill No. 1045 does not become effective, section
18 15-40.3-06 of the North Dakota Century Code is amended and reenacted as follows:

19 **15-40.3-06. Local school boards - Standards.** Each school board shall adopt
20 standards for the acceptance and rejection of applications for open enrollment as provided in
21 section 15-40.3-01. The standards may include the capacity of a program, class, grade level,
22 or school building. The standards may not include previous academic achievement,
23 participation in extracurricular activities, disabilities, English language proficiency, or previous
24 disciplinary proceedings. The school board of the admitting district may determine that the
25 district may not accept applications for open enrollment under this chapter. A school district
26 participating in an open enrollment program may not give or offer to give a student
27 remuneration, or directly or indirectly exert influence upon the student or the student's family, in
28 order to encourage participation in the open enrollment program ~~for the purpose of having the~~
29 ~~student participate in varsity athletic activities. However, any student who participated in varsity~~
30 ~~athletic activities during the 1992-93 school year, at a school in a district other than the~~
31 ~~student's district of residence or at a school outside the boundary within which the student~~

1 ~~would normally attend school may continue to participate in varsity athletics at that school for~~
2 ~~the duration of the student's high school career.~~

3 **SECTION 3. AMENDMENT.** If House Bill No. 1045 does not become effective, section
4 15-40.3-07 of the 1999 Supplement to the North Dakota Century Code is amended and
5 reenacted as follows:

6 **15-40.3-07. Students not subject to this chapter.** A student, who, as the result of
7 dissolution or reorganization, resides in a district other than the one the student chooses to
8 attend at the time of the dissolution or reorganization, is not subject to the provisions of this
9 chapter and may attend school in the chosen school district. The student may not be
10 considered a student in average daily membership in the student's school district of residence
11 for purposes of section 15-40.3-02.

12 **SECTION 4. AMENDMENT.** Section 15.1-31-01 of the North Dakota Century Code as
13 created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is
14 amended and reenacted as follows:

15 **15.1-31-01. Open enrollment - Procedure.**

- 16 1. By February first of the school year preceding the year of enrollment, a parent who
17 wishes to enroll a student in a North Dakota school district other than the student's
18 district of residence shall file an application for approval with the board of the
19 student's district of residence. The superintendent of public instruction shall make
20 the application forms available in each school district.
- 21 2. By March first of the school year preceding the year of enrollment, the school
22 board of the student's district of residence shall act on the application, notify the
23 parent of the board's decision within five days, and if the application is approved,
24 immediately transmit the application to the admitting district.
- 25 3. By April first of the school year preceding the year of enrollment, the board of the
26 admitting district shall approve or deny the application. The board of the admitting
27 district shall notify the board of the district of residence and the student's parent of
28 its decision within five days.
- 29 4. Notice of intent to enroll in the admitting district obligates the student to attend the
30 admitting district during the following school year unless the school boards of the

- 1 resident and the admitting districts agree in writing to allow the student to transfer
2 back to the resident district or the student's parent relocates to another district.
- 3 5. All applications must be reviewed in the order they are received.
- 4 6. A student whose school district of residence does not offer the grade level in which
5 the student requires enrollment may not participate in open enrollment. For
6 purposes of determining whether the grade level in which the student requires
7 enrollment is offered, the several school districts cooperating with each other for
8 the joint provision of education services under a plan approved by the
9 superintendent of public instruction must be considered to be a single district.
- 10 7. A child placed for purposes other than education in a group or residential care
11 facility or in a residential treatment center is not eligible for open enrollment under
12 this section.
- 13 8. The board of a school district of residence and the board of an admitting district
14 shall waive the application, consideration, and approval dates in this section for
15 any student who, together with the student's parent, moves from the student's
16 school district of residence to another school district and who wishes to enroll in a
17 school district other than the district to which the student moved.
- 18 9. The board of a school district of residence and the board of an admitting district
19 shall waive the application, consideration, and approval dates in this section for
20 any student who, together with the student's parent, moves into this state from out
21 of state and who wishes to enroll in a school district other than the district to which
22 the student moved.

23 **SECTION 5. AMENDMENT.** Section 15.1-31-06 of the North Dakota Century Code as
24 created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is
25 amended and reenacted as follows:

26 **15.1-31-06. Open enrollment - School boards - Standards.**

- 27 1. The board of each school district shall set standards for the acceptance and denial
28 of applications for admittance under open enrollment as provided in section
29 15.1-31-01. The standards may address the capacity of a program, class, grade
30 level, or school building. The standards may not address previous academic

1 achievement, participation in extracurricular activities, disabilities, English language
2 proficiency, or previous disciplinary proceedings.

3 2. A board may also determine that applications for admittance under open
4 enrollment, in accordance with this chapter, will not be considered.

5 3. A school district participating in an open enrollment program may not give or offer
6 to give a student remuneration, or directly or indirectly exert influence on the
7 student or the student's family, in order to encourage participation in the open
8 enrollment program ~~for the purpose of having the student participate in varsity~~
9 ~~athletic activities.~~

10 **SECTION 6. AMENDMENT.** Section 15.1-31-07 of the North Dakota Century Code as
11 created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is
12 amended and reenacted as follows:

13 **15.1-31-07. Students not subject to this chapter.** If a student, as a result of a school
14 district dissolution or reorganization, resides in a district other than the one the student chooses
15 to attend at the time of the dissolution or reorganization, the student is not subject to the
16 provisions of this chapter and may attend school in the chosen school district. The student may
17 not be considered a student in average daily membership in the student's school district of
18 residence for purposes of section 15.1-31-02.
