5	SECTION 1. APPROPRIATION. The funds provided in	n this section, or so much of the	
6	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		
7	treasury, not otherwise appropriated, and from special funds derived from federal funds and		
8	other income, to the department of corrections and rehabilitation for the purpose of defraying		
9	the expenses of its various divisions, for the biennium beginning July 1, 2001, and ending		
10	June 30, 2003, as follows:

21	SECTION 2. LAND BOARD DISTRIBUTIONS. The estimated income line item in			
22	subdivision 2 of section 1 of this Act includes \$502,823 from permanent funds managed for the			
23	benefit of the youth correctional center by the board of university and school lands.			
24	SECTION 3. LINE ITEM TRANSFER AUTHORITY. The director of the department of			
25	corrections and rehabilitation may transfer from the salary and wages line item in subdivision 1			
26	of section 1 of this Act to various line items in subdivisions 2 and 3 of section 1 of this Act			
27	appropriation authority of up to \$125,000 to provide for salary equity adjustments.			
28	SECTION 4. LEGISLATIVE INTENT. In view of significant budget increases to the			
29	department of corrections and rehabilitation over the past five biennia, which divert funds from			
30	other public purposes, it is the intent of the legislative assembly that the department of			
31	corrections and rehabilitation prepare and submit to the fifty-eighth legislative assembly, an

- 1 analysis identifying the causes for the growth in the state's prison population and make specific
- 2 recommendations on how the growth in population may be reduced or eliminated. The
- 3 department of corrections and rehabilitation shall enlist support from the legislative council,
- 4 office of management and budget, state's attorneys, law enforcement community, attorney
- 5 general's office, and the judiciary.
