- 1 A BILL for an Act to amend and reenact section 23-38-02 of the North Dakota Century Code,
- 2 relating to the community health grant program; to provide for an appropriation; and to provide
- 3 for an exemption.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Section 23-38-02 of the North Dakota Century Code is
6 amended and reenacted as follows:

23-38-02. Community health grant program advisory committee - Duties of state health officer.

9 1. The state health officer shall establish a community health grant program advisory 10 committee and shall appoint, after consulting with the governor, appropriate 11 members to advise the state department of health in the development of a 12 community health grant program. The state health officer, who shall be is the 13 chairman of the committee, shall appoint to the committee the state tobacco 14 control administrator; one high school student; one student of a postsecondary 15 institution in the state; one representative of a nongovernmental tobacco control 16 organization; and one law enforcement officer. In addition to the members 17 appointed by the state health officer, the committee must include: 18 a. One individual appointed by the North Dakota Indian affairs commission: 19 b. One individual appointed by the North Dakota public health association; 20 c. The superintendent of public instruction or the superintendent's designee; 21 d. An academic researcher with expertise in tobacco control and health 22 promotion intervention, appointed by the dean of the university of North 23 Dakota school of medicine and health sciences; and

e. One physician appointed by the North Dakota medical association.

1	2.	Members of the committee who are not state employees or officers are entitled to		
2		be co	mpensated at a rate of sixty-two dollars and fifty cents per day and are	
3		entitled to mileage and expenses as provided by law for state officers and		
4		employees. A state employee who is a member of the committee must receive		
5		that employee's regular salary and is entitled to mileage and expenses, to be paid		
6		by the employing agency.		
7	3.	The state department of health, with the committee's involvement, shall provide		
8		assistance to:		
9		a. I	Evaluate programs;	
10		b. I	Promote media advocacy by working with statewide media associations;	
11		с.	Implement smoke-free policies by involving antitobacco groups in promoting	
12		t	the need for smoke-free public buildings;	
13		d. '	Work to reduce minors' access to tobacco in all communities;	
14		e.	Facilitate the coordination of program components with the local level;	
15		f.	Involve state agencies, law enforcement, and local government in the	
16		i	administration and management of the program; and	
17		g	Assist the state in screening and implementing the grants.	
18	4.	The s	state health officer shall monitor the implementation of the community health	
19		grant program. The state health officer shall provide reports a report to the		
20		legislative council regarding the implementation of the program not later than		
21		December 31, 2001, and November 1, 2002 September 30, 2004. Upon request,		
22		the state health officer shall provide assistance to any interim legislative committee		
23		that may study the implementation of the community health grant program and		
24	shall recommend any legislation that the community health grant program advisory			
25		comn	nittee considers appropriate to improve the community health grant program.	
26	26 SECTION 2. APPROPRIATION. There is appropriated out of any moneys in the			
27	community health trust fund, not otherwise appropriated, the sum of \$100,000, or so much of			
28	the sum as may be necessary, to the state department of health for the purpose of funding the			
29	community health grant program advisory committee, for the biennium beginning July 1, 2003,			
30	and ending June 30, 2005.

SECTION 3. APPROPRIATION. There is appropriated out of any moneys in the community health trust fund, not otherwise appropriated, the sum of \$500,000, or so much of the sum as may be necessary, to the state department of health for the purpose of funding grants to cities and counties with a one dollar local match for every three dollars of state funds for city and county employee tobacco education and cessation programs and for the purpose of funding state employee tobacco education and cessation programs, for the biennium beginning July 1, 2003, and ending June 30, 2005.

8 SECTION 4. EXEMPTION. The appropriation contained in section 5 of chapter 250 of 9 the 2001 Session Laws is not subject to the provisions of section 54-44.1-11. Any unexpended 10 funds from this appropriation are available, in addition to any other moneys appropriated, for 11 grants for the purpose of funding city, county, and state employee tobacco education and 12 cessation programs under section 3 of this Act, for the biennium beginning July 1, 2003, and 13 ending June 30, 2005.
