- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
- 2 corrections and rehabilitation; to authorize a request for a supplemental appropriation from the
- 3 fifty-ninth legislative assembly; and to declare an emergency.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the
6	funds as may be necessary, are appropriated out of any moneys in the general fund in the state
7	treasury, not otherwise appropriated, and from special funds derived from federal funds and
8	other income, to the department of corrections and rehabilitation for the purpose of defraying
9	the expenses of the department of corrections and rehabilitation, for the biennium beginning
10	July 1, 2003, and ending June 30, 2005, as follows:
11	Field services \$21,632,548
12	Prisons division 71,185,029
13	Juvenile community services 9,615,306
14	Youth correctional center <u>11,476,494</u>
15	Total all funds \$113,909,377
16	Less estimated income <u>30,992,766</u>

18	SECTION 2. CRIME VICTIMS RESTITUTION AND GIFT FUND. The sum of
19	\$100,000, or so much of the sum as may be necessary, included in the field services line item
20	in section 1 of this Act, is from the crime victims restitution and gift fund and shall be used by
21	the department of corrections and rehabilitation for the purposes provided in section

23 **SECTION 3. STATE PENITENTIARY LAND FUND.** The sum of \$82,500, or so much of the sum as may be necessary, included in the youth correctional center line item in section 1

54-23.4-05, for the biennium beginning July 1, 2003, and ending June 30, 2005.

- of this Act, is from the state penitentiary land fund and shall be used by the department of corrections and rehabilitation for capital projects at the youth correctional center, for the biennium beginning July 1, 2003, and ending June 30, 2005.
- 4 SECTION 4. SUPPLEMENTAL GENERAL FUND APPROPRIATION REQUEST. The 5 general fund amount included in the various line items in section 1 of this Act for salaries and 6 wages to be paid by the department of corrections and rehabilitation may be up to \$1,616,717 7 less than the required amount, depending upon the actual number of vacant positions realized 8 by the department and the department's ability to fill newly authorized positions in a timely 9 manner. In recognition of this possible budget shortfall, the department of corrections and 10 rehabilitation may request a supplemental general fund appropriation of up to \$1,616,717 from 11 the fifty-ninth legislative assembly if determined necessary by the department to pay salaries 12 and wages for the biennium beginning July 1, 2003, and ending June 30, 2005.
 - **SECTION 5. EMERGENCY.** The prisons division line item in section 1 of this Act includes \$95,500 from the general fund and \$1,326,227 from other funds for capital construction projects, which amounts are declared to be an emergency measure.
