## 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the 6 funds as may be necessary, are appropriated out of any moneys in the general fund in the state 7 treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying 8 the expenses of the governor, for the biennium beginning July 1, 2003, and ending June 30,

6	and eighty-eight thousand and eighty-two dollars thereafter.	
7	SECTION 4. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is	
8	amended and reenacted as follows:	
9	54-08-03. Salary of lieutenant governor. The annual salary of the lieutenant	
10	governor is sixty-six thousand three hundred eighty dollars through June 30, 2002	
11	December 31, 2003, and sixty-seven thousand seven hundred eight forty-eight dollars through	
12	December 31, 2004, and sixty-eight thousand three hundred eighty-nine dollars thereafter.
