## ENGROSSED HOUSE BILL NO. 1375

1 A BILL for an Act to create and enact a new section to chapter 54-60 of the North Dakota  
2 Century Code, relating to creation of the beginning again North Dakota pilot program by which  
3 the department of commerce develops a data base of skills and other assets of two North  
4 Dakota communities; to provide a continuing appropriation; and to provide an expiration date.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1.** A new section to chapter 54-60 of the North Dakota Century Code is  
7 created and enacted as follows:

8 **Beginning again North Dakota pilot program - Report to legislative council -**  
9 **Continuing appropriation.**

- 10 1. The department shall implement and administer a beginning again North Dakota  
11 pilot program. The purpose of the program is to develop a data base of skills and  
12 other assets of communities and residents to be used to advance the internal and  
13 external attitude and image of this state and the communities in this state. The  
14 department shall implement this program in one city with a population of not more  
15 than one thousand five hundred and one city with a population of more than one  
16 thousand five hundred but not more than three thousand five hundred.
- 17 2. The department shall assemble state and local asset data from a broad range of  
18 sources. The sources for data may include the department, Bank of North Dakota,  
19 game and fish department, state historical society, Indian affairs commission, job  
20 service North Dakota, parks and recreation department, department of public  
21 instruction, university system, workforce safety and insurance, and state and local  
22 public or private entities. The nature of the data regarding skills and other assets  
23 may cover a broad range of information that may be valuable to advance the  
24 attitude or image of the state and communities in the state. The data may include

- 1 natural resources, real estate, educational resources, cultural resources,  
2 vocational resources, financial resources, and infrastructure resources.
- 3 3. The department shall use the information assembled in the data base to assist in  
4 strategic plans for development. Additionally, the department may use the  
5 information in the data base to assist local developers in strategic plans for  
6 development.
- 7 4. The department may contract with a public or private third party to provide any or  
8 all of the services necessary to implement and administer the program. The  
9 department may solicit support and contributions from public and private sources  
10 for the purpose of furthering the program. The department may charge a fee for  
11 the services provided to the community. This fee may not exceed twenty-five  
12 percent of the value of the services offered. The department shall deposit in a  
13 special account in the general fund of the state treasury all funds collected under  
14 this subsection. All funds deposited under this section are appropriated to the  
15 department on a continuing basis for the purpose of furthering the program.
- 16 5. During the 2007-08 interim, the commissioner shall provide a report to the  
17 legislative council regarding the implementation of the program, any successes  
18 and failures of the program, and whether the program should be continued or be  
19 continued and expanded to additional communities.

20 **SECTION 2. EXPIRATION DATE.** This Act is effective through July 31, 2009, and  
21 after that date is ineffective.
