## ENGROSSED HOUSE BILL NO. 1272

1 A BILL for an Act to amend and reenact section 4-28-03 of the North Dakota Century Code,  
2 relating to membership of the wheat commission; and to provide for a legislative council study.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 4-28-03 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **4-28-03. Wheat commission - Members.** ~~There is hereby created the~~

7 1. The North Dakota state wheat commission ~~which~~ consists of seven members.

8 One member must be appointed or elected from each of the districts of the state  
9 established by ~~the provisions of~~ this chapter and one member must be appointed  
10 or elected from the state at large. Each member, except the member from the  
11 state at large, must be a ~~bona fide~~ resident of and a qualified elector in the district  
12 the member represents; and must have farming operations in such the district, and  
13 ~~must have been actually engaged in the production of wheat and have derived a~~  
14 ~~substantial portion of the member's income therefrom for at least five years next~~  
15 ~~preceding the member's appointment or election.~~ The member from the state at  
16 large must have similar qualifications except as limited by district lines. An  
17 individual is not eligible to be a member of the wheat commission if that individual  
18 requested a refund under section 4-28-07 during the three-year period before the  
19 date on which the term sought by the individual would commence. This ineligibility  
20 does not apply to an individual who requested a refund because of an  
21 overpayment, as provided in subdivision c of subsection 2 of section 4-28-07.

22 Each member of the wheat commission must be actively engaged in the  
23 production of wheat. A member of the wheat commission who elects not to plant  
24 wheat for one growing cycle may continue to serve on the commission if the

1           member continues to be actively involved in farming. If a member elects not to  
2           plant wheat for more than one growing cycle, the member is deemed to have  
3           resigned and the commission shall declare the member's office vacant. A member  
4           of the wheat commission is not eligible to receive a refund under section 4-28-07;  
5           however, a member may request a refund because of an overpayment, as  
6           provided in subdivision c of subsection 2 of section 4-28-07. The commission shall  
7           declare a member's position vacant if the member fails to attend two consecutive  
8           commission meetings.

9           2. Not more than sixty days prior to expiration of the term of the member from the  
10           state at large, a nominating committee consisting of the agriculture commissioner,  
11           the president of the North Dakota crop improvement association, the director of the  
12           North Dakota agricultural experiment station, the director of the North Dakota state  
13           university extension service, the president of the North Dakota farm bureau, the  
14           president of the North Dakota farmers union, the president of the North Dakota  
15           grain dealers association, the president of the North Dakota grain growers  
16           association, and an individual who is a resident of this state and a member of the  
17           United States durum growers association, or their duly authorized representatives,  
18           shall submit to the governor a list of three names and within sixty days after  
19           expiration of the term the governor shall appoint, from the nominees so named, the  
20           member at large to the commission.

21           3. Each member of the commission shall hold office for a term of four years and until  
22           the member's successor has been selected and has qualified except that the  
23           commissioners elected and serving from the first and fourth districts shall hold  
24           office for terms ending on June 30, 1984; the commissioners elected and serving  
25           from the second and fifth districts shall hold office for terms ending on June 30,  
26           1985; and the commissioners elected and serving from the third and sixth districts  
27           shall hold office for terms ending on June 30, 1982; and the commissioner  
28           appointed and serving as the state at large member shall hold office for a term  
29           ending on June 30, 1983. No producer is entitled to serve more than three terms.

30           4. At least sixty days prior to the expiration of the term of office of a commissioner  
31           representing any district, a meeting of producers must be held in each county in

1 the district for the purpose of electing a county representative. The county agent  
2 shall call such meeting by publishing notice in the official newspaper of the county  
3 for two successive weeks, the last publication to be not less than five nor more  
4 than ten days prior to the meeting. The meeting must be held at a central location  
5 within the county and must be called to order by the county agent. The county  
6 agent, in cooperation with the cooperative extension service, shall conduct all  
7 elections under this section in each county in the manner the county agent deems  
8 fair and reasonable, except that a producer may vote only in the producer's county  
9 of residence. Votes must be canvassed by the county agent and certified by the  
10 county agent with the name and post-office address of the elected county  
11 representative to the director of the North Dakota state university extension service  
12 who shall thereupon, as expeditiously as possible, call a meeting of the county  
13 representatives of the district. Notice of such meeting must be sent to each county  
14 representative by registered or certified mail not less than five days prior to the  
15 meeting which must be held at a central location within the district. At such district  
16 meeting, the county representatives shall elect one of their number as the district  
17 member of the commission. The ballots at such meeting must be canvassed by  
18 the North Dakota state university extension service and the result of election  
19 certified to the governor by the director. To be eligible to hold the position of  
20 county representative, an individual must be actively engaged in the production of  
21 wheat. A county representative who elects not to plant wheat for one growing  
22 cycle may continue to serve as a county representative if the individual continues  
23 to be actively involved in farming. If a county representative elects not to plant  
24 wheat for more than one growing cycle, the member is deemed to have resigned  
25 and the commission shall declare the member's position vacant. Additional  
26 meetings of county representatives may be called by the state wheat commission  
27 for the purpose of promoting its programs. All expenses of all such meetings and  
28 elections must be paid from commission funds. County representatives must be  
29 reimbursed for expenses necessarily incurred in attending meetings and  
30 performing other official duties on the same basis as other state officers.

1           5. Any vacancy occurring on the commission other than by expiration of term of office  
2                   must be filled by the county representatives who shall elect one of their number as  
3                   the district member of the commission for the remainder of the unexpired term. If  
4                   the vacancy is from the state at large, appointment must be made from three  
5                   nominations submitted by the nominating committee as in the case of the original  
6                   appointment.

7           **SECTION 2. LEGISLATIVE COUNCIL STUDY.** The legislative council shall consider  
8   studying, during the 2005-06 interim, the feasibility and desirability of revising the process for  
9   appointing or electing individuals to the North Dakota wheat commission. The legislative  
10   council shall report its findings and recommendations, together with any legislation required to  
11   implement the recommendations, to the sixtieth legislative assembly.
