ENGROSSED HOUSE BILL NO. 1002

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 secretary of state and public printing; to define matching requirements for the Help America
3 Vote Act; to amend and reenact section 54-09-05 of the North Dakota Century Code, relating to
4 the salary of the secretary of state; and to declare an emergency.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. BASE LEVEL FUNDING INFORMATION.** The amounts identified in this
7 section represent the base level funding component appropriated to the secretary of state in
8 section 3 of this Act as follows:

21 **SECTION 3. APPROPRIATION.** The funds provided in this section, or so much of the
22 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
23 treasury, not otherwise appropriated, and from special funds derived from federal funds and
24 other income, to the secretary of state for the purpose of defraying the expenses of the
25 secretary of state and public printing, for the biennium beginning July 1, 2005, and ending
26 June 30, 2007, as follows:

13 **SECTION 4. COLLECTIONS FROM COUNTIES - GENERAL FUND REVENUE.** The
14 secretary of state shall collect \$76,100 from counties to reimburse the general fund for a portion
15 of the state matching requirement provided for federal election reform funds for the biennium
16 beginning July 1, 2005, and ending June 30, 2007. All funds collected by the secretary of state
17 under this section must be deposited in the general fund.

18 **SECTION 5. AMENDMENT.** Section 54-09-05 of the North Dakota Century Code is
19 amended and reenacted as follows:

20 **54-09-05. Salary of secretary of state.** The annual salary of the secretary of state is
21 ~~sixty four thousand seven hundred forty two dollars through December 31, 2001, sixty six~~
22 ~~seventy thousand six hundred eighty four~~ fifty-nine dollars through June 30, ~~2002~~ 2006, and
23 ~~sixty eight~~ seventy-two thousand eighteen eight hundred sixty-one dollars thereafter.

24 **SECTION 6. EMERGENCY.** The election reform line item in subdivision 1 of section 3
25 of this Act is declared to be an emergency measure.
