

HOUSE BILL NO. 1080

1 A BILL for an Act to amend and reenact sections 54-24.4-01 and 54-24.4-05 of the North
2 Dakota Century Code, relating to the North Dakota library coordinating council.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 54-24.4-01 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **54-24.4-01. North Dakota library coordinating council - Members - Term.** The
7 North Dakota library coordinating council consists of eleven members. The president of the
8 North Dakota library association is an ex officio, voting member of the council. The state
9 librarian is an ex officio nonvoting member of the council. The governor shall appoint nine
10 members to the council, one of whom must represent special libraries, one of whom must
11 represent public higher education institution libraries, one of whom must represent private
12 higher education institution libraries, one of whom must represent school libraries, two of whom
13 must represent public libraries, one of whom must represent disabled, economically
14 disadvantaged, and minority populations, and two citizens at large. All appointed members,
15 except citizens at large, must be practicing librarians. The governor shall take into account
16 reasonable geographic considerations when appointing members of the council. The term of
17 each member is three years. If at any time during a member's term, the member ceases to
18 possess the qualifications required by this section, the member's office is deemed vacant and
19 the governor shall appoint a qualified representative to complete the term of office. No member
20 may be appointed to serve more than two consecutive three-year terms.

21 **SECTION 2. AMENDMENT.** Section 54-24.4-05 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **54-24.4-05. North Dakota library coordinating council - Duties.** The North Dakota
24 library coordinating council shall:

- 9 encourage electronic networking among all types of libraries.
- 10 5. Strengthen ~~and support~~ the state library in its role of coordinating ~~the extension~~
- 11 ~~and improvement of~~ and enriching library ~~services~~ service in the state.
- 12 6. ~~Strengthen and support regional library cooperatives in~~ Support and strengthen
- 13 library cooperative ventures, including consortia, regional associations, and
- 14 partnerships, in their role of extending and improving library services in the state.
- 15 7. ~~Inform the public and governing bodies of the goals and objectives of the council~~
- 16 ~~and of the role of libraries in assuring equitable access to information technology~~
- 17 ~~and basic library services.~~ Promote equitable access to information resources and
- 18 library services to persons throughout the state.
- 19 8. ~~Support literacy projects for all ages.~~ Promote the services of libraries and
