ENGROSSED SENATE BILL NO. 2099

Introduced by

Transportation Committee

(At the request of the Department of Transportation)

1 A BILL for an Act to amend and reenact sections 39-06-30 and 39-06-34, subsection 1 of
2 section 39-06-42, sections 39-16-03.1 and 39-20-01, subsection 2 of section 39-20-04, and
3 subsection 1 of section 39-20-04.1 of the North Dakota Century Code, relating to the meaning
4 of the term conviction, time required for a decision after a hearing, driving while license is
5 suspended, when entries on a driving record are confidential, the implied consent advisory for
6 refusal to submit to alcohol test, procedure to negate effect of a refusal, and suspension of
7 person under twenty-one years of age for driving with a prohibited alcohol concentration; and to
8 repeal sections 39-16-30 and 39-16.1-21 of the North Dakota Century Code, relating to driving
9 while a license is suspended.

10 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

11 **SECTION 1. AMENDMENT.** Section 39-06-30 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **39-06-30. Conviction - Meaning and effect.** For purposes of this title the term
14 "conviction" means a final order or judgment of conviction by the North Dakota supreme court
15 ~~or~~, any lower court having jurisdiction, a tribal court, or a court in another state provided that no
16 appeal is pending and the time for filing a notice of appeal has elapsed. Subject to the filing of
17 an appeal, a conviction includes those instances when:

- 18 1. A sentence is imposed and suspended;
- 19 2. Imposition of a sentence is deferred under subsection 4 of section 12.1-32-02; or
- 20 3. There is a forfeiture of bail or collateral deposited to secure a defendant's
21 appearance in court and the forfeiture has not been vacated.

22 **SECTION 2. AMENDMENT.** Section 39-06-34 of the North Dakota Century Code is
23 amended and reenacted as follows:

1 **39-06-34. Director may require reexamination.** In addition to other powers set forth
2 in this chapter, the director, having good cause to believe that a licensed operator is
3 incompetent or otherwise not qualified to be licensed, may upon written notice of at least five
4 days to the licensee require the licensee to submit to such physical, mental, or driver's
5 examination as may be deemed necessary. If the director has good cause to believe that the
6 licensed operator presents an immediate danger to the motoring public, the director may
7 immediately, and without prior notice, suspend the operator's license pending the examination.
8 The notice of suspension must provide the operator with the opportunity for a hearing within
9 five days of the receipt of the notice of suspension. When a hearing is requested it must be
10 conducted under section 39-06-33 and the hearing officer's recommended decision must be
11 rendered within two days of the conclusion of the hearing. Upon the conclusion of such
12 examination the director shall take action as may be appropriate and may suspend or revoke
13 the license of such person or permit the licensee to retain the license, or may issue a license
14 subject to restrictions as permitted under section 39-06-17. Refusal or neglect of the licensee
15 to submit to such examination shall be grounds for suspension or revocation of the license.

16 **SECTION 3. AMENDMENT.** Subsection 1 of section 39-06-42 of the North Dakota
17 Century Code is amended and reenacted as follows:

18 1. Except as provided in ~~chapters 39-16 and 39-16.1~~ and section 39-06.1-11, any
19 person who drives a motor vehicle on a highway or on public or private areas to
20 which the public has a right of access for vehicular use in this state while that
21 person's license or privilege so to do is suspended or revoked in any jurisdiction is
22 guilty of a class B misdemeanor for the first, second, or third offense within a
23 five-year period. Any subsequent offense within the same five-year period is a
24 class A misdemeanor.

25 **SECTION 4. AMENDMENT.** Section 39-16-03.1 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **39-16-03.1. Entries on driver record abstract confidential.** Notwithstanding any
28 other provision of this chapter, the following entries on a driver record or abstract are not
29 available to the public, except for statistical purposes, other than by order of a court of
30 competent jurisdiction accompanied by a fee of twenty-five dollars:

31 1. An entry more than three years old.

1 2. After the period of suspension ceases, an entry concerning a suspension under
2 subsection 4, 5, 6, or 7 of section 39-06-03 or subsection 2, 5, or 6 of section
3 39-06-32.

4 3. An entry concerning a suspension as the result of a person under twenty-one
5 years of age who has an alcohol concentration of at least two one-hundredths of
6 one percent but under ~~ten~~ eight one-hundredths of one percent by weight within
7 two hours after driving or being in actual physical control of a vehicle.

8 **SECTION 5. AMENDMENT.** Section 39-20-01 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **39-20-01. Implied consent to determine alcohol and drug content of blood.** Any
11 person who operates a motor vehicle on a highway or on public or private areas to which the
12 public has a right of access for vehicular use in this state is deemed to have given consent, and
13 shall consent, subject to the provisions of this chapter, to a chemical test, or tests, of the blood,
14 breath, saliva, or urine for the purpose of determining the alcohol, other drug, or combination
15 thereof, content of the blood. As used in this chapter the word "drug" means any drug or
16 substance or combination of drugs or substances which renders a person incapable of safely
17 driving, and the words "chemical test" or "chemical analysis" mean any test to determine the
18 alcohol, or other drug, or combination thereof, content of the blood, breath, saliva, or urine,
19 approved by the state toxicologist under this chapter. The test or tests must be administered at
20 the direction of a law enforcement officer only after placing the person, except persons
21 mentioned in section 39-20-03, under arrest and informing that person that the person is or will
22 be charged with the offense of driving or being in actual physical control of a vehicle upon the
23 public highways while under the influence of intoxicating liquor, drugs, or a combination thereof.
24 For the purposes of this chapter, the taking into custody of a child under section 27-20-13 or a
25 person under twenty-one years of age satisfies the requirement of an arrest. The law
26 enforcement officer shall also inform the person charged that refusal of the person to submit to
27 the test determined appropriate will result in a revocation for up to ~~three~~ four years of the
28 person's driving privileges. The law enforcement officer shall determine which of the tests is to
29 be used. When a person under the age of eighteen years is taken into custody for violating
30 section 39-08-01 or an equivalent ordinance, the law enforcement officer shall attempt to
31 contact the person's parent or legal guardian to explain the cause for the custody. Neither the

1 law enforcement officer's efforts to contact, nor any consultation with, a parent or legal guardian
2 may be permitted to interfere with the administration of chemical testing requirements under
3 this chapter. The law enforcement officer shall mail a notice to the parent or legal guardian of
4 the minor within ten days after the test results are received or within ten days after the minor is
5 taken into custody if the minor refuses to submit to testing. The notice must contain a
6 statement of the test performed and the results of that test; or if the minor refuses to submit to
7 the testing, a statement notifying of that fact. The attempt to contact or the contacting or
8 notification of a parent or legal guardian is not a precondition to the admissibility of chemical
9 test results or the finding of a consent to, or refusal of, chemical testing by the person in
10 custody.

11 **SECTION 6. AMENDMENT.** Subsection 2 of section 39-20-04 of the North Dakota
12 Century Code is amended and reenacted as follows:

- 13 2. A person's driving privileges are not subject to revocation under subdivision a of
14 subsection 1 if all of the following criteria are met:
- 15 a. An administrative hearing is not held under section 39-20-05;
 - 16 b. The person mails an affidavit to the director within twenty-five days after the
17 temporary operator's permit is issued. The affidavit must state that the
18 person:
 - 19 (1) Intends to voluntarily plead guilty to violating section 39-08-01 or
20 equivalent ordinance within twenty-five days after the temporary
21 operator's permit is issued;
 - 22 (2) Agrees that the person's driving privileges must be suspended as
23 provided under section 39-06.1-10;
 - 24 (3) Acknowledges the right to a section 39-20-05 administrative hearing
25 and section 39-20-06 judicial review and voluntarily and knowingly
26 waives these rights; and
 - 27 (4) Agrees that the person's driving privileges must be revoked as provided
28 under this section without an administrative hearing or judicial review, if
29 the person does not plead guilty within twenty-five days after the
30 temporary operator's permit is issued, or the court does not accept the
31 guilty plea, or the guilty plea is withdrawn;

- 1 c. The person pleads guilty to violating section 39-08-01 or equivalent ordinance
2 within twenty-five days after the temporary operator's permit is issued;
- 3 d. The court accepts the person's guilty plea and a notice of that fact is mailed to
4 the director within twenty-five days after the temporary operator's permit is
5 issued;
- 6 e. A copy of the final order or judgment of conviction evidencing the acceptance
7 of the person's guilty plea is received by the director prior to the return or
8 reinstatement of the person's driving privileges; and
- 9 f. The person has never been convicted under section 39-08-01 or equivalent
10 ordinance.

11 **SECTION 7. AMENDMENT.** Subsection 1 of section 39-20-04.1 of the North Dakota
12 Century Code is amended and reenacted as follows:

- 13 1. After the receipt of a person's operator's license, if taken under section 39-20-03.1
14 or 39-20-03.2, and the certified report of a law enforcement officer and if no written
15 request for hearing has been received from the arrested person under section
16 39-20-05, or if that hearing is requested and the findings, conclusion, and decision
17 from the hearing confirm that the law enforcement officer had reasonable grounds
18 to arrest the person and test results show that the arrested person was driving or
19 in physical control of a vehicle while having an alcohol concentration of at least
20 eight one-hundredths of one percent by weight or, with respect to a person under
21 twenty-one years of age, an alcohol concentration of at least two one-hundredths
22 of one percent by weight at the time of the performance of a test within two hours
23 after driving or being in physical control of a motor vehicle, the director shall
24 suspend the person's operator's license as follows:
- 25 a. For ninety-one days if the person's driving record shows that, within the five
26 years preceding the date of the arrest, the person has not previously violated
27 section 39-08-01 or equivalent ordinance or the person's operator's license
28 has not previously been suspended or revoked under this chapter and the
29 violation was for an alcohol concentration of at least eight one-hundredths of
30 one percent by weight or, with respect to a person under twenty-one years of

- 1 age, an alcohol concentration of at least two one-hundredths of one percent
2 by weight, and under eighteen one-hundredths of one percent by weight.
- 3 b. For one hundred eighty days if the operator's record shows the person has
4 not violated section 39-08-01 or equivalent ordinance within five years
5 preceding the last violation and the last violation was for an alcohol
6 concentration of at least eighteen one-hundredths of one percent by weight.
- 7 c. For three hundred sixty-five days if the person's driving record shows that,
8 within the five years preceding the date of the arrest, the person has once
9 previously violated section 39-08-01 or equivalent ordinance or the person's
10 operator's license has once previously been suspended or revoked under this
11 chapter with the last violation or suspension for an alcohol concentration
12 under eighteen one-hundredths of one percent by weight.
- 13 d. For two years if the person's driving record shows that within the five years
14 preceding the date of the arrest, the person's operator's license has once
15 been suspended, revoked, or issuance denied under this chapter, or for a
16 violation of section 39-08-01 or equivalent ordinance, with the last violation or
17 suspension for an alcohol concentration of at least eighteen one-hundredths
18 of one percent by weight or if the person's driving record shows that within the
19 five years preceding the date of arrest, the person's operator's license has at
20 least twice previously been suspended, revoked, or issuance denied under
21 this chapter, or for a violation of section 39-08-01 or equivalent ordinance, or
22 any combination thereof, and the suspensions, revocations, or denials
23 resulted from at least two separate arrests with the last violation or
24 suspension for an alcohol concentration of under eighteen one-hundredths of
25 one percent by weight.
- 26 e. For three years if the operator's record shows that within five years preceding
27 the date of the arrest, the person's operator's license has at least twice
28 previously been suspended, revoked, or issuance denied under this chapter,
29 or for a violation of section 39-08-01 or equivalent ordinance, or any
30 combination thereof, and the suspensions, revocations, or denials resulted
31 from at least two separate arrests and the last violation or suspension was for

1 an alcohol concentration of at least eighteen one-hundredths of one percent
2 by weight.

3 **SECTION 8. REPEAL.** Sections 39-16-30 and 39-16.1-21 of the North Dakota Century
4 Code are repealed.
