ENGROSSED SENATE BILL NO. 2336

1 A BILL for an Act to amend and reenact sections 16.1-07-01, 16.1-07-05, 16.1-07-06,  
2 16.1-07-08, 16.1-07-08.1, and 16.1-07-12 of the North Dakota Century Code, relating to  
3 absentee voting.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 16.1-07-01 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **16.1-07-01. Absent voter - Who may vote.**

- 8 1. Any qualified elector of this state, including an individual who is in the armed forces  
9 of the United States, is in the merchant marine of the United States, or is a United  
10 States citizen living outside the United States who resided in this state immediately  
11 prior to the individual's departure from the United States, may vote an absent  
12 voter's ballot at any general, special, or primary state election, any county election,  
13 or any city or school district election.
- 14 2. A qualified elector who is a citizen of the United States ~~and~~, lives outside the  
15 United States, and who resided in this state immediately before the individual's  
16 departure from the United States or a citizen of the United States who is eighteen  
17 years of age or older ~~and~~, has never lived in the United States, and whose parent  
18 is a qualified elector of the state may vote absentee in this state pursuant to this  
19 chapter if the individual:
- 20 a. Does not maintain a domicile;
- 21 b. Is not registered to vote in any other state, territory, or possession of the  
22 United States;
- 23 c. Is not voting in any other state, territory, or possession of the United States;
- 24 and

- 1           d. Possesses a valid passport or card of identity and registration issued under  
2           the authority of the secretary of state of the United States.  
3           Such an elector may vote only in federal elections, which means any election held  
4           solely or in part for the purpose of electing or nominating any candidate for the  
5           office of president, vice president, presidential elector, member of the United  
6           States senate, or member of the United States house of representatives.  
7           3. An elector who votes by absentee ballot may not vote in person at the same  
8           election.

9           **SECTION 2. AMENDMENT.** Section 16.1-07-05 of the North Dakota Century Code is  
10          amended and reenacted as follows:

11           **16.1-07-05. Time for applying for ballot - Applications and voting for uniformed**  
12          **citizens and for citizens living outside the United States - Emergency situations -**  
13          **Sufficient time for application and ballot return.**

- 14           1. At any time in an election year, any qualified elector may apply to the county  
15           auditor, the auditor or clerk of the city, or the business manager of the school  
16           district, as the case may be, by facsimile or otherwise, for an official ballot to be  
17           voted at that election. A voter may obtain an application form for an absent voter's  
18           ballot for a general, special, primary, or county election from either the county  
19           auditor or a city auditor. The application form, ~~for a member of the United States~~  
20           ~~armed forces or the United States merchant marine or for a qualified elector living~~  
21           ~~outside the United States,~~ must include a space for the applicant to indicate  
22           whether the application is for all statewide elections in the calendar year or only for  
23           the election that is immediately after the date of the application.  
24           2. An applicant who is a qualified elector and on active duty as a member of the  
25           United States armed forces or the United States merchant marine may receive an  
26           absentee ballot by mail, facsimile, or electronic mail. In the event that returning the  
27           voted ballot by mail is not practicable, qualified electors meeting the stated criteria  
28           of this subsection may return a voted ballot and other required documents to the  
29           county auditor by means of facsimile transmission or electronic mail. To return a  
30           voted ballot and other required documents by electronic mail, the eligible voter  
31           must have access to the technology to scan the documents, save the documents

1           in a secure format approved by the secretary of state, and return the documents as  
2           an electronic mail attachment directly to the electronic mail address assigned by  
3           the auditor, clerk, or business manager for that purpose prior to midnight in the  
4           voter's county of residence on the day before the election. The secretary of state  
5           shall develop written guidelines relating to security measures for voted ballots  
6           returned by electronic mail.

7           3. Spouses, children, or other dependents of active duty members of the United  
8           States armed forces or merchant marine who are qualified electors and stationed  
9           as a family outside the United States are granted the same absentee voting rights  
10           as the individual's spouse, parent, or guardian has under subsection 2.

11           4. ~~An applicant who is a member of the United States armed forces or the United~~  
12           ~~States merchant marine living outside the United States or is a~~ qualified elector  
13           living outside the United States may ~~apply for and vote by facsimile if otherwise~~  
14           ~~qualified to apply for and vote by absentee ballot. An auditor, clerk, or business~~  
15           ~~manager may send and receive facsimile absentee ballot applications and~~  
16           ~~facsimile absentee ballots to any individual eligible to apply for and vote by~~  
17           ~~facsimile under this section~~ receive an absentee ballot by mail, facsimile, or  
18           electronic mail. If returning the voted ballot by mail is not practicable, a qualified  
19           elector may return a voted ballot and other required documents to the county  
20           auditor by means of facsimile transmission or electronic mail. The elector must  
21           have access to the technology to scan the documents, save the documents in a  
22           secure format approved by the secretary of state, and return the documents as an  
23           electronic mail attachment directly to the electronic mail address assigned by the  
24           auditor, clerk, or business manager for that purpose before midnight in the voter's  
25           county of residence on the day before the election. The secretary of state shall  
26           develop written guidelines relating to security measures for voted ballots returned  
27           by electronic mail.

28           5. No auditor or clerk may issue ballots for absentee voters on the day of the election  
29           except to persons prevented from voting in person on the day of the election due  
30           to an emergency. A person requesting an absentee ballot on the day of the  
31           election due to an emergency must do so through an agent as set forth in this

1 chapter. An agent may represent only one person. The absentee ballot must be  
2 returned to the county auditor's office by four p.m. on the day of the election.

3 6. A completed application must be submitted to the appropriate election official in a  
4 timely manner so as to allow the applicant to receive, complete, and mail the  
5 absent voter's ballot before the day of the election.

6 **SECTION 3. AMENDMENT.** Section 16.1-07-06 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **16.1-07-06. Application form.**

9 1. Application for an absent voter's ballot must be made on a form, prescribed by the  
10 secretary of state, to be furnished by the proper officer of the county, city, or school  
11 district in which the applicant is an elector, on any form, approved by the secretary  
12 of state, or any blank containing the following information:

- 13 a. The applicant's name.  
14 b. The applicant's current or most recent North Dakota residential address.  
15 c. The applicant's mailing address.  
16 d. The applicant's current home telephone number.  
17 e. The election for which the ballot is being requested.  
18 f. The date of the request.  
19 g. An affirmation that the applicant has resided, or will reside, in the precinct for  
20 at least thirty days next preceding the election.  
21 h. The applicant's signature.  
22 i. A space for the voter to include the voter's precinct or voting location, if  
23 known.

24 If the applicant is unable to sign the applicant's name, the applicant shall mark (X)  
25 on the application in the presence of a disinterested person. The disinterested  
26 person shall print the name of the person marking the X below the X and shall sign  
27 ~~that~~ the disinterested person's own name following the printed name together with  
28 the notation "witness to the mark".

29 2. A The application for a qualified elector ~~absent from the state is not required to file~~  
30 ~~an application for an absent voter's ballot for any statewide election if either of the~~  
31 ~~following apply~~ serving on active duty as a member of the United States armed

1           forces, merchant marine, or a family member who is a qualified elector and  
2           stationed outside the United States together with the individual's spouse, parent, or  
3           guardian must include the following additional information if the voter desires to  
4           vote by facsimile or electronic mail:

5           a.   ~~The elector is a member, or spouse or dependent of a member, of the United~~  
6               ~~States armed forces or merchant marine living outside the United States.~~

7               Facsimile telephone number; or

8           b.   ~~The elector is a United States citizen living outside the United States~~

9               Electronic mail address.

10           ~~If the qualified elector furnishes the county auditor with a current mailing address~~  
11           ~~and the elector's residential address, the county auditor either shall mail to the~~  
12           ~~qualified elector a ballot with a return envelope and instructions or send to the~~  
13           ~~qualified elector the ballot and instructions by facsimile for voting for any statewide~~  
14           ~~election in that calendar year.~~

15           3.   The application for a qualified elector living outside the United States must include  
16               a facsimile telephone number or electronic mail address if the voter desires to vote  
17               by facsimile or electronic mail.

18           **SECTION 4. AMENDMENT.** Section 16.1-07-08 of the North Dakota Century Code is  
19           amended and reenacted as follows:

20               **16.1-07-08. Delivering ballots - Envelope accompanying - Statement on**  
21               **envelope - Challenging electors voting by absentee ballot - Inability of elector to sign**  
22               **name.**

23           1.   Upon receipt of an application for an official ballot properly filled out and duly  
24               signed, or as soon thereafter as the official ballot for the precinct in which the  
25               applicant resides has been prepared, the county auditor, city auditor, or business  
26               manager of the school district, as the case may be, shall send to the absent voter  
27               by mail, at the expense of the political subdivision conducting the election, one  
28               official ballot, or personally deliver the ballot to the applicant or the applicant's  
29               agent, which agent may not, at that time, be a candidate for any office to be voted  
30               upon by the absent voter. The agent shall sign the agent's name before receiving  
31               the ballot and deposit with the auditor or business manager of the school district,

1 as the case may be, authorization in writing from the applicant to receive the ballot  
2 or according to requirements set forth for signature by mark. The auditor or  
3 business manager of the school district, as the case may be, may not provide an  
4 absent voter's ballot to a person acting as an agent who cannot provide a signed,  
5 written authorization from an applicant. No person may receive compensation,  
6 including money, goods, or services, for acting as an agent for an elector, nor may  
7 a person act as an agent for more than four electors in any one election. A voter  
8 voting by absentee ballot may not require the political subdivision providing the  
9 ballot to bear the expense of the return postage for an absentee ballot.

10 2. If there is more than one ballot to be voted by an elector of the precinct, one of  
11 each kind must be included and an envelope must be enclosed with the ballot or  
12 ballots. The front of the envelope must bear the official title and post-office  
13 address of the officer supplying the voter with the ballot and upon the other side a  
14 printed ~~statement~~ voter's affidavit in substantially the following form:

19 Under penalty of possible criminal prosecution for making a false  
20 statement, I swear that I reside at the residential address provided  
21 above, that I have resided in my precinct for at least thirty days  
22 next preceding the election, and this is the only ballot I will cast  
23 in this election.

26 If the absent voter is unable to sign the voter's name, the voter shall mark (X) on  
27 the statement in the presence of a disinterested person. The disinterested person  
28 shall print the name of the person marking the X below the X and shall sign ~~that~~  
29 the disinterested person's own name following the printed name together with the  
30 notation "witness to the mark".

- 1           3. ~~The county auditor, city auditor, or business manager of the school district, as the~~  
2           ~~ease may be, may challenge the right of anyone to vote an absent voter's ballot~~  
3           ~~whom that officer knows or has reason to believe is not a qualified elector. When~~  
4           ~~challenging a voter who has applied for an absentee voter's ballot, the election~~  
5           ~~official shall follow the procedures and use the affidavit provided for in section~~  
6           ~~16.1-05-06 and include a voter's affidavit with the outgoing absentee voter's ballot~~  
7           ~~along with an explanation that the voter's right to vote is being challenged and that~~  
8           ~~the voter's affidavit must be completed and returned with the voter's absentee~~  
9           ~~voter's ballot to be accepted.~~
- 10          4. Each person requesting an absent voter's ballot under this chapter must be  
11          provided a set of instructions, prescribed by the secretary of state, sufficient to  
12          describe the process of voting by absent voter's ballot. The voting instructions  
13          must contain a statement informing the individual that the individual is entitled to  
14          complete the absent voter's ballot in secrecy.
- 15          ~~5.~~ 4. Each individual requesting an absent voter's ballot under this chapter who cannot  
16          read the English language or who because of blindness or other disability is unable  
17          to mark the voter's ballot, upon request, may receive the assistance of any person  
18          of the voter's choice, other than the voter's employer, an officer or agent of the  
19          voter's union, a candidate running in that election, or a relative of a candidate as  
20          described in subsection 2 of section 16.1-05-02, in marking the voter's ballot.

21           **SECTION 5. AMENDMENT.** Section 16.1-07-08.1 of the North Dakota Century Code  
22 is amended and reenacted as follows:

23           **16.1-07-08.1. Procedures for voting with special write-in or federal write-in**  
24 **absentee ballot.**

- 25           1. Notwithstanding any other provision of this chapter, a qualified absentee elector  
26           may apply to the county auditor for a special write-in absentee ballot. This ballot  
27           may be used to vote for presidential electors and members of the United States  
28           senate and of the United States house of representatives.
- 29           2. The application for a special write-in absentee ballot may be made on a form  
30           prescribed by the secretary of state. In order to qualify for a special write-in  
31           absentee ballot, the voter shall state on the application that the voter is unable to

1           vote by regular absentee ballot or in person due to requirements of military service  
2           or due to living in isolated or extremely remote areas of the world.

3           3. Upon receipt of the application, the county auditor shall issue the special write-in  
4           absentee ballot, which must be in the form prescribed by the secretary of state.  
5           The ballot must permit the elector to vote by writing in a party preference for each  
6           office, the names of specific candidates for each office, or the name of the person  
7           whom the voter prefers for each office.

8           4. If the voter is temporarily residing outside the United States or is a member of the  
9           United States armed forces, merchant marine, or a family member and a qualified  
10           elector, the voter may use the federal write-in absentee ballot in general, special,  
11           and primary elections for local, state, or federal offices.

12           5. If the voter is residing outside the United States, or is a member of the United  
13           States armed forces, merchant marine, or a family member, and a qualified elector  
14           stationed outside the United States, the voter may use the federal write-in  
15           absentee ballot transmission envelope as an absentee ballot application  
16           simultaneously with the submission of the federal write-in absentee ballot if the  
17           voter is otherwise eligible to vote absentee in the jurisdiction where the request is  
18           submitted.

19           **SECTION 6. AMENDMENT.** Section 16.1-07-12 of the North Dakota Century Code is  
20           amended and reenacted as follows:

21           **16.1-07-12. Opening ballot - Voting or rejecting - Depositing in ballot box -**  
22           **Preserving.** At any time between the opening and closing of the polls on election day, the  
23           election judges of the relevant precinct first shall open the outer envelope and compare the  
24           signature on such application for an absent voter's ballot with the signature on the statement  
25           provided for in section 16.1-07-08. If the judges find that the statement is sufficient and that the  
26           signatures correspond, and that the applicant is then a duly qualified elector of such precinct  
27           and has not voted at the election, they shall open the absent voter's envelope in such manner  
28           as not to destroy the statement thereon. They shall take out the ballot or ballots contained  
29           therein without unfolding the same, or permitting the same to be opened or examined, and after  
30           ~~stamping and initialing~~ or initialing the same as other ballots are ~~stamped and initialed~~ or  
31           initialed, they shall deposit the ballot in the proper ballot box and show in the pollbook of the

1 election that the elector has voted. If the statement is found to be insufficient, or that the  
2 signatures do not correspond, or that the applicant is not then a duly qualified elector of the  
3 precinct, the vote may not be allowed, but without opening the absent voter's envelope, the  
4 election inspector or election judge shall mark across the face thereof "rejected as defective" or  
5 "rejected as not an elector", as the case may be. These rejected ballots are then turned over to  
6 the county canvassing board for final determination of eligibility. The subsequent death of an  
7 absentee voter after having voted by absentee ballot does not constitute grounds for rejecting  
8 such ballot.
