3	SECTION 1. BASE LEVEL FUNDING INFORMATION. The amounts identified in this		
4	section represent the base level funding component appropriated to the highway patrol in

22	SECTION 3. APPROPRIATION. The funds provided in this section, or so much of the		
23	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		

24 treasury, not otherwise appropriated, and from special funds derived from federal funds and

  - **SECTION 4. SPECIAL FUNDS TRANSFER.** The less estimated income line item in section 3 of this Act includes the sum of \$7,521,970, or so much of the sum as may be necessary, from the state highway tax distribution fund which may be transferred at the direction of the superintendent of the highway patrol for the purpose of defraying the expenses

of the highway patrol during the biennium beginning July 1, 2005, and ending June 30, 2007.

SECTION 5. PAYMENTS TO HIGHWAY PATROL OFFICERS. Each patrol officer of the state highway patrol is entitled to receive from funds appropriated in section 3 of this Act an amount not to exceed one hundred seventy dollars per month for the biennium beginning July 1, 2005, and ending June 30, 2007. The payments are in lieu of reimbursement for meals and other expenses, except lodging, while in travel status within the state of North Dakota or while at their respective home stations. The amounts must be paid at the time and in the same manner as salaries are paid to members of the highway patrol and may be paid without the presentation of receipts or other memorandums.
