9 SECTION 4. SPECIAL FUNDS TRANSFER. The less estimated income line item in section 3 of this Act includes the sum of \$7,516,175, or so much of the sum as may be 10 11 necessary, from the state highway tax distribution fund which may be transferred at the 12 direction of the superintendent of the highway patrol for the purpose of defraying the expenses 13 of the highway patrol during the biennium beginning July 1, 2005, and ending June 30, 2007. 14 SECTION 5. PAYMENTS TO HIGHWAY PATROL OFFICERS. Each patrol officer of the state highway patrol is entitled to receive from funds appropriated in section 3 of this Act an 15 16 amount not to exceed one hundred seventy dollars per month for the biennium beginning 17 July 1, 2005, and ending June 30, 2007. The payments are in lieu of reimbursement for meals 18 and other expenses, except lodging, while in travel status within the state of North Dakota or 19 while at their respective home stations. The amounts must be paid at the time and in the same 20 manner as salaries are paid to members of the highway patrol and may be paid without the 21 presentation of receipts or other memorandums.
