23	SECTION 3. APPROPRIATION. The funds provided in this section, or so much of the		

funds as may be necessary, are appropriated out of any moneys in the general fund in the state

- 1 treasury, not otherwise appropriated, and from special funds derived from federal funds and
- 2 other income, to the state auditor for the purpose of defraying the expenses of the state auditor,
- 3 for the biennium beginning July 1, 2005, and ending June 30, 2007, as follows:

- SECTION 4. POLITICAL SUBDIVISION AUDIT FEES. Section 3 of this Act includes
- an appropriation of up to \$1,441,970 in funds generated by the state auditor from political
- subdivision audit service fees for the period beginning July 1, 2005, and ending June 30, 2007.
- Any amount in excess of \$1,441,970 must be deposited in the state auditor operating account
- 14 and made available for appropriation after June 30, 2007.
- SECTION 5. AMENDMENT. Section 54-10-10 of the North Dakota Century Code is amended and reenacted as follows:
- 17 **54-10-10. Salary of state auditor.** The annual salary of the state auditor is sixty-four
- 18 <u>seventy</u> thousand seven hundred forty-two thirty-nine dollars through December 31, 2001
- 19 June 30, 2006, sixty-six and may not exceed seventy-three thousand six five hundred
- 20 eighty four sixty-nine dollars through June 30, 2002, and sixty-eight thousand eighteen dollars
- 21 thereafter.
