## ENGROSSED HOUSE BILL NO. 1009

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the agriculture

- 2 commissioner; to amend and reenact sections 4-01-19, 4-01-21, 4-22-22, 4-37-03, 4-37-04,
- 3 and 19-18-04 of the North Dakota Century Code, relating to the pride of Dakota program, the
- 4 salary of the agriculture commissioner, compensation of supervisors of soil conservation
- 5 districts, the agriculture in the classroom program, and pesticide registration fees; and to
- 6 provide for transfers.

## 7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 SECTION 1. BASE LEVEL FUNDING INFORMATION. The amounts identified in this
9 section represent the base level funding component appropriated to the agriculture
10 commissioner in section 3 of this Act as follows:

5 **SECTION 4. ESTIMATED INCOME - ENVIRONMENT AND RANGELAND** 6 **PROTECTION FUND.** The estimated income line item in section 3 of this Act includes the sum 7 of \$2,805,077, or so much of the sum as may be available, from the environment and 8 rangeland protection fund for the purpose of defraying the expenses of various agriculture 9 department programs, for the biennium beginning July 1, 2005, and ending June 30, 2007. 10 SECTION 5. ANHYDROUS AMMONIA STORAGE INSPECTION FUND. The 11 estimated income line item in section 3 of this Act includes the sum of \$61,410, or so much of 12 the sum as may be available, from the anhydrous ammonia storage inspection fund for the 13 purpose of defraying the expenses of regulating anhydrous ammonia storage facilities, for the 14 biennium beginning July 1, 2005, and ending June 30, 2007.

SECTION 6. ESTIMATED INCOME - GAME AND FISH FUND. The estimated income
line item in section 3 of this Act includes the sum of \$700,000, or so much of the sum as may
be necessary, from the game and fish department operating fund for the purpose of defraying
the expenses of various agriculture department programs for the biennium beginning July 1,
2005, and ending June 30, 2007.

20 **SECTION 7. TRANSFER.** The commissioner shall transfer \$200,000 from the 21 environment and rangeland protection fund to the minor use pesticide fund.

SECTION 8. AMENDMENT. Section 4-01-19 of the North Dakota Century Code is
 amended and reenacted as follows:

4-01-19. Marketing bureau. The agriculture commissioner of this state shall establish
and maintain a marketing bureau for the purpose of gathering and disseminating statistical
information on agricultural marketing problems of the state and engaging in marketing services
of agricultural products. Any moneys received or generated by the pride of Dakota program
must be deposited in the general fund in the state treasury. <u>General fund expenditures for</u>
pride of Dakota conferences are limited to the amount of revenue deposited in the general fund
for this purpose.

SECTION 9. AMENDMENT. Section 4-01-21 of the North Dakota Century Code is
 amended and reenacted as follows:

4-01-21. Salary of agriculture commissioner. The annual salary of the agriculture
commissioner is sixty six thousand five hundred nine dollars through December 31, 2001,
sixty eight seventy-one thousand five nine hundred four seventy dollars through June 30, 2002
2006, and sixty-nine seventy-four thousand eight hundred seventy four forty-nine dollars
thereafter.

8 SECTION 10. AMENDMENT. Section 4-22-22 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 4-22-22. Supervisors - Terms of office - Vacancies - Removal - Compensation -11 **Expenses.** At the general election to be held in 1972, three district supervisors must be 12 elected. The candidate receiving the largest number of votes is elected for a six-year term; the 13 candidate receiving the second highest number of votes is elected for a four-year term; and the 14 candidate receiving the third highest number of votes is elected for a two-year term. At each 15 succeeding general election, one supervisor must be elected for a term of six years, or until the 16 successor is duly elected and qualified, to each expiring or vacant term. In newly formed 17 districts, three supervisors must be elected at the first general election following the district's 18 organization. The candidate receiving the largest number of votes is elected for a six-year 19 term; the candidate receiving the second highest number of votes is elected for a four-year 20 term; and the candidate receiving the third highest number of votes is elected for a two-year 21 term. At each succeeding general election, one supervisor must be elected for a term of six 22 years, or until the successor is duly elected and qualified, to each expiring or vacant term. The 23 county auditor of the county or counties in which the district lies shall return to the secretary of 24 state before four p.m. on the tenth day following any general election a certified abstract of the 25 votes cast in the county at the election for each candidate for district supervisor. The secretary 26 of state shall canvass the returns and issue certificates of election under chapter 16.1-15.

In order to be eligible for election to the office of supervisor, candidates must be land
occupiers and physically living in the district. Candidates must be elected on a nonpartisan
ballot. In case the office of any supervisor, for any reason, becomes vacant, the remaining
members of the board of supervisors shall, with the advice and consent of the committee, fill
the vacancy by appointment. If vacancies occur in the office of two supervisors, the remaining

supervisor and the committee shall fill the vacancy; and in case the offices of all supervisors of
a district become vacant, the committee shall fill the vacancies by appointment. A supervisor
appointed to fill a vacancy holds office until the next general election. A supervisor elected to
fill a vacancy serves the balance of the unexpired term in which the vacancy occurred.

5 Any soil conservation district, upon resolution of the three elected supervisors, may 6 appoint two additional supervisors who shall serve for a term of one year from and after the 7 date of their appointment. Such supervisors must be appointed by a majority of the three 8 elected supervisors and have all the powers, voting privileges, duties, and responsibilities of 9 elected supervisors, except that the expense allowances of the appointed supervisors must be 10 paid by the local soil conservation district concerned. As far as possible, the appointed 11 supervisors shall represent interests within the district which are not represented by the elected 12 supervisors.

Any supervisor of a soil conservation district may, after notice given and hearing held in
accordance with chapter 28-32, be removed from office by the committee.

The supervisors of soil conservation districts are entitled to receive, upon a majority vote of the supervisors, up to twenty-five sixty-two dollars and fifty cents for attending each regular or special meeting or for attending other meetings or events in the performance of their official duties as compensation for their services. Supervisors of soil conservation districts are entitled to receive travel and subsistence expenses necessarily incurred in attending district, state, or other meetings. The compensation and all other expenses including travel incurred by district supervisors while transacting district business must be paid from district funds.

SECTION 11. AMENDMENT. Section 4-37-03 of the North Dakota Century Code is
 amended and reenacted as follows:

24 4-37-03. Purpose - Powers and duties. The agriculture in the classroom council shall 25 may provide grants and contracts to individuals and organizations that conduct contract with 26 any person for the provision of an agriculture in the classroom program to develop, the 27 development of agricultural curriculum activities and train applicable to students from 28 kindergarten through grade twelve, and the training of teachers in these agricultural curriculum 29 activities for grades kindergarten through twelve in this state's public school system. The 30 council shall work with all educators, including teachers, the superintendent of public 31 instruction, the department of career and technical education, the United States department of

1 agriculture, and the state agriculture commissioner in accomplishing its this purpose. The 2 council shall render services consistent with this purpose which include may: 3 1. Consultations Consult with the state superintendent of public instruction, the 4 department of career and technical education, the state agriculture commissioner, 5 and the United States department of agriculture. 6 2. Preparation of Prepare instructional, informational, and reference publications on 7 the North Dakota agricultural economy and rural lifestyles. 8 3. Provide training programs for public school teachers in <del>developed</del> agricultural 9 curriculum activities. 10 4. Encourage research on and identification of new instructional, informational, and 11 reference publications relating to this state's agricultural economy and rural 12 lifestyles. 13 5. Monitor the quality and condition of the agriculture in the classroom program. 14 SECTION 12. AMENDMENT. Section 4-37-04 of the North Dakota Century Code is amended and reenacted as follows: 15 16 4-37-04. Gifts and grants. In order to carry out its duties under this chapter, the The 17 agriculture in the classroom council may contract for and accept and expend private 18 contributions, gifts, and grants-in-aid from the federal government, private industry, and other 19 sources. Additional income must be spent The council shall expend any moneys received 20 under this section for the designated purpose designated, if any, in if a purpose is included as a 21 condition of the gift, grant, or donation. The funds must be used to contract with individuals or 22 organizations that conduct an agriculture in the classroom program council may use all other 23 moneys received under this section to carry out the purposes of this chapter. 24 SECTION 13. AMENDMENT. Section 19-18-04 of the North Dakota Century Code is 25 amended and reenacted as follows: 26 19-18-04. (Effective through June 30, 2005 2007) Registration - Fees. 27 1. Any person before selling or offering for sale any pesticide for use within this state 28 shall file biennially with the commissioner an application for registration of the 29 pesticide. The application must: 30 a. Give the name and address of each manufacturer or distributor. 31 b. Give the name and brand of each product to be registered.

1 2. Give the name and brand of each product to be registered.

2 3. Be accompanied by a current label of each product to be registered.

4. Be accompanied by a registration fee of three hundred dollars for each product to
be registered. At the close of each calendar month, the commissioner shall
transmit to the state treasurer all moneys received for the registrations. The state
treasurer shall credit fifty dollars for each registered product to the general fund in
the state treasury and the remainder of the registration fee for each registered
product to the environment and rangeland protection fund.

9 5. Be accompanied by a material safety data sheet for each product to be registered.
10 The commissioner may require an applicant or registrant to provide efficacy, toxicity,
11 residue, and any other data necessary to determine if the pesticide will perform its intended
12 function without unreasonable adverse effects on the environment. If the commissioner finds
13 that the application conforms to law, the commissioner shall issue to the applicant a certificate
14 of registration of the product.

15 Each registration covers a designated two-year period beginning January first of each 16 even-numbered year and expiring December thirty-first of the following year. A certificate of 17 registration may not be issued for a term longer than two years, and is not transferable from 18 one person to another, or from the ownership to whom issued to another ownership. A penalty 19 of fifty percent of the license or registration fee must be imposed if the license or certificate of 20 registration is not applied for on or before January thirty-first following the expiration date. Each 21 product must go through a two-year discontinuance period in order to clear all outstanding 22 products in the channel of trade.

This section does not apply to a pesticide sold by a retail dealer if the registration fee has been paid by the manufacturer, jobber, or any other person, as required by this section.
