- <u>4.</u> <u>"Sponsor" means any person who organizes or provides the facility for any activity involving livestock.</u>

Liability of sponsor for activities involving livestock.

- 1. Because livestock by their very nature can react unpredictably in a variety of situations, including those involving sound, sudden movement, an unfamiliar object, the presence of an individual, or the presence of another animal, the sponsor of an activity involving livestock is not liable for injury to or for the death of a spectator or a participant in the activity, except as provided in subsection 3.
- Neither a spectator nor a participant, nor the personal representative of either, may maintain an action against or recover from the sponsor of any activity involving livestock for an injury to or the death of a spectator or a participant engaged in the activity.
- 3. Subsection 1 does not prevent or limit the liability of the sponsor of an activity involving livestock:
  - a. If the sponsor provides any equipment or tack and the equipment or tack causes the injury;
  - b. If the sponsor owns, leases, rents, or is otherwise in lawful possession and control of the land or facility upon which the spectator or participant sustains an injury because of a latent condition that the sponsor knew was dangerous;
  - c. If the sponsor commits an act or omission that constitutes willful or wanton disregard for the safety of the spectator or the participant and that act or omission causes the injury;
  - d. If the sponsor intentionally injures the spectator or the participant;
  - e. Under products liability provisions as set forth in products liability laws; or

f. Under liability provisions in chapter 36-11.

Statement of liability - Warning sign. The sponsor of an activity involving livestock shall post and maintain a sign and shall include in every contract governing the activity language warning that there are inherent risks in the activity and stating that the sponsor is not liable for any injury or damage resulting from the activity except as otherwise provided in this chapter."

  - h. A used commodity is advantageous to the state and the commodity is available only on short notice.
  - i. The commodity is a component or replacement part for which there is no commercially available substitute and which can be obtained only from the manufacturer.
  - j. Compatibility with equipment currently owned by the state is essential to the proper functioning of that equipment.
  - k. The agency provides documentation indicating that the services or the circumstances are of such a nature that deviation from the procurement procedure is appropriate."

- 3. A county agency that places a child in an out-of-state facility shall report the following information to the department of human services:
  - a. The out-of-state facility at which the child was placed and the reasons for the placement;
  - b. The in-state facilities at which placement was considered;
  - c. The reasons for not choosing an in-state facility;
  - d. The reasons why the child did not meet the established admissions criteria for in-state facilities; and
  - e. If the child met the admission criteria, the reasons why the safety of the child or the safety of the community could not be met at an in-state facility.

**SECTION 2. REPORT TO LEGISLATIVE COUNCIL.** The department of human services shall compile the child placement information received from the county agencies pursuant to subsection 3 of section 1 of this Act. Before July first of each year, the department shall report this information, together with facility placement and education costs, to the legislative council."
