Eng. SB 2372 provides an income tax credit of \$250 for classroom supplies purchased by a teacher.

There are approximately 6,424 teachers in North Dakota. Assuming they all make or will make qualifying purchases of classroom supplies, and further assuming they all have sufficient income tax liabilities to offset with this tax credit, the provisions of Eng. SB 2372 are expected to reduce state general fund revenues by an estimated \$3.2 million in the 2007-09 biennium.
