- 1 A BILL for an Act to create and enact chapter 43-15.2 of the North Dakota Century Code,
- 2 relating to the creation of a legend prescription drug and device donation and repository
- 3 program; and to provide an appropriation.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. Chapter 43-15.2 of the North Dakota Century Code is created and

6 enacted as follows:

7	<u>43-</u>	5.2-01. Definitions. In addition to the definitions under section 43-15-01, in this		
8	chapter unless the context otherwise requires:			
9	<u>1.</u>	"Donor" means a person that donates to the program legend drugs, devices, or		
10		supplies needed to administer such drugs.		

- <u>Participant</u> means a practitioner or pharmacy that has elected to participate in the
 program and accepts legend drugs, devices, and supplies from donors for the
 program.
- 14 <u>3.</u> <u>"Program" means the legend drug donation and repository program established</u>
 15 <u>under this chapter.</u>
- 16 <u>4.</u> "Supplies" means any supplies used in the administration of a legend drug.

17 <u>43-15.2-02. Administration.</u>

- 181.The state board of pharmacy shall establish and contract with a third party to19administer a legend drug donation and repository program.
- 2. The board may develop and maintain a participant registry for the program. A
 participant registry created under this subsection must include the name, address,
 and telephone number of the participants. A participant registry created under this
 subsection must be available through the board or on the board's web site.

1 The board may cooperate with nongovernmental organizations to maintain a 3. 2 web-based list of legend drugs, devices, or supplies that have been donated and 3 are available through the program and the participants from which the donated 4 items may be available. 5 43-15.2-03. Conditions for participation. 6 A donor may donate legend drugs, devices, or supplies to the program through a 1. 7 practitioner or pharmacy that meets the criteria established for such participation. 8 Legend drugs, devices, or supplies may not be donated directly to a specific 9 patient and donated items may not be resold. 10 The items donated to the program may be prescribed for use by an individual by a <u>2.</u> 11 practitioner who is authorized by law to prescribe and only a participant may 12 dispense donated items. 13 43-15.2-04. Conditions for acceptance of a donation. 14 A drug donated, prescribed, or dispensed under the program must be in the 1. 15 original, unopened, sealed, and tamper-evident unit dose packaging, except a drug 16 packaged in single-unit doses may be accepted and dispensed if the outside 17 packaging has been opened and the single-unit-dose package is unopened. 18 A drug may not be accepted or dispensed under the program if the drug has 2. 19 reached its expiration date or if the drug is adulterated or misbranded as 20 determined under subsection 3. 21 Before being dispensed to an eligible individual, the legend drugs, devices, and 3. 22 supplies donated under the program must be inspected by a pharmacist to 23 determine that the legend drugs, devices, and supplies are not adulterated or 24 misbranded. 25 43-15.2-05. Storage, distribution, and dispensing. 26 A participant that accepts donated legend drugs, devices, or supplies under the 1. 27 program shall comply with all applicable provisions of state and federal law relating 28 to the storage, distribution, and dispensing of the donated legend drugs, devices, 29 or supplies.

2		hundred fifty percent of the medicaid prescription dispensing fee for dispensing				
3		donated legend drugs, devices, or supplies under the program.				
4	<u>3.</u>	A dispenser of donated legend drugs, devices, or supplies may not submit a claim				
5		or otherwise seek reimbursement from any public or private third-party payer for				
6		the cost of donated legend drugs, devices, or supplies dispensed to any eligible				
7		individual under the program. A public or private third-party payer is not required				
8		to provide reimbursement to a dispenser for the cost of donated legend drugs,				
9		devices, or supplies dispensed to any eligible individual under the program.				
10	<u>43-</u>	15.2-06. Liability.				
11	<u>1.</u>	A donor of legend drugs, devices, or supplies, or any participant in the program,				
12		that exercises reasonable care in donating, accepting, distributing, prescribing, and				
13		dispensing legend drugs, devices, or supplies under the program and the rules				
14		adopted to implement this chapter is immune from civil or criminal liability and from				
15		professional disciplinary action of any kind for any injury, death, or loss to personal				
16		property relating to such activities.				
17	<u>2.</u>	In the absence of intentional misconduct, a pharmaceutical manufacturer is				
18		immune from civil or criminal liability for any claim, injury, death, or loss to person				
19		or property arising from transfer, donation, dispensing, or acceptance of any				
20		legend drugs, devices, or supplies under this chapter, including liability for failure				
21		to transfer or communicate product or consumer information regarding the				
22		transferred legend drugs, devices, or supplies as well as the expiration date of the				
23		legend drugs, devices, or supplies under the program.				
24	43-15.2-07. Recordkeeping.					
25	<u>1.</u>	A participant shall retain separate records detailing the receipt, distribution, and				
26		dispensing of legend drugs, devices, and supplies under this program.				
27	<u>2.</u>	The records of receipt must include:				
28		a. The name and address of the donor;				
29		b. The drug name and strength;				
30		c. The manufacturer of the legend drugs, devices, or supplies;				
31		d. The manufacturer lot number;
