8	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		
9	treasury, not otherwise appropriated, and from special funds derived from federal funds and		
10	other income, to job service North Dakota, for the purpose of defraying the expenses of that		
11	agency, for the biennium beginning July 1, 2007, and ending June 30, 2009, as follows.

21	SECTION 4. APPROPRIATION - REED ACT FUNDS - UNEMPLOYMENT		
22	INSURANCE COMPUTER MODERNIZATION. The special appropriation of \$7,300,000 in		
23	section 3 of this Act is from federal Reed Act funds made available to the state by the federal		
24	Reed Act distributions made in federal fiscal years 1957, 1958, 1999, and 2002, pursuant to		
25	section 903 of the Social Security Act. This sum, or so much of the sum as may be necessary,		
26	is for the purpose of developing a modernized unemployment insurance computer system, for		
27	the biennium beginning July 1, 2007, and ending June 30, 2009.		
28	SECTION 5. APPROPRIATION. All federal funds received by job service North		
29	Dakota in excess of those funds appropriated in section 3 of this Act are appropriated, for the		
30	biennium beginning July 1, 2007, and ending June 30, 2009.
