- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor; and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
- 3 Century Code, relating to the salaries of the governor and lieutenant governor.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. BASE LEVEL FUNDING INFORMATION. The	amounts identified in this	
6	section represent the base level funding component appropriated to the office of the governor in		
7	section 3 of this Act as follows:

4	SECTION 3. APPROPRIATION. The funds provided in this section, or so much of the		
5	funds as may be necessary, are appropriated out of any moneys in the general fund in the state		
6	treasury, not otherwise appropriated, and from special funds derived from federal funds and		
7	other income, to the office of the governor for the purpose of defraying the expenses of the		
8	office of the governor, for the biennium beginning July 1, 2007, and ending June 30, 2009, as		
9	follows:

21	SECTION 4. APPROPRIATION - AUTHORIZATION - GOVERNOR'S OFFICE. In		
22	addition to the amounts appropriated to the governor's office in section 3 of this Act, there is		
23	appropriated any additional income from federal or other funds which may be become available		
24	to the agency for the biennium beginning July 1, 2007, and ending June 30, 2009.		
25	SECTION 5. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is		
26	amended and reenacted as follows:		
27	54-07-04. Salary of governor. The annual salary of the governor is eighty-eight		
28	ninety-six thousand nine one hundred twenty-six eighty-three dollars through June 30, 2006		
29	2008, and ninety-two one hundred thousand four hundred eighty-three thirty-one dollars		
30	thereafter.		

- SECTION 6. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is amended and reenacted as follows:
- 3 **54-08-03. Salary of lieutenant governor.** The annual salary of the lieutenant
- 4 governor is sixty-nine seventy-four thousand thirty-five six hundred sixty-eight dollars through
- 5 June 30, 2006 <u>2008</u>, and seventy-one <u>seventy-seven</u> thousand seven <u>six</u> hundred
- 6 <u>ninety-seven</u> <u>fifty-five</u> dollars thereafter.
