- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the state fair
- 2 association; to provide legislative intent; and to declare an emergency.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, to the state fair association for the purpose of defraying the expenses of the state fair association, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

- 5 **SECTION 3. ADDITIONAL INCOME APPROPRIATION.** Any other income, including
- 6 funds from federal acts, private grants, gifts, and donations, or from other sources received by
- 7 the state fair association for the grandstand construction project in addition to the amount
- 8 included in the estimated income line item in section 1 of this Act, except as otherwise provided
- 9 by law, is appropriated for the grandstand construction project, for the biennium beginning
- 10 July 1, 2009, and ending June 30, 2011.
- 11 **SECTION 4. EMERGENCY.** The appropriation of \$18,000,000 for the grandstand
- 12 project in the capital assets line item in section 1 of this Act is declared to be an emergency
- 13 measure.
