4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury not otherwise appropriated, to the state treasurer for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2011, and ending June 30, 2013, as follows:

- 9 **SECTION 3. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is amended and reenacted as follows:
- 11 **54-11-13.** Salary of state treasurer.
- The annual salary of the state treasurer is seventy-eighteighty-five thousand ninethree
- hundred thirty dollars through June 30, 20102012, and eighty-twoeighty-seven thousand eight
- 14 hundred forty-fiveninety dollars thereafter.
