1 A BILL for an Act to provide an appropriation for defraying the expenses of the state auditor; to-

2 provide an appropriation to the legislative council; and to amend and reenact section 54-10-10

3 of the North Dakota Century Code, relating to the salary of the state auditor.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury, not otherwise appropriated, and from special funds derived from federal funds and
other income, to the state auditor for the purpose of defraying the expenses of the state auditor,

8	professionalism, customer feedback, efficiency, staffing review, and reporting. The performance-
9	review must be completed by July 1, 2012.
10	SECTION 3. AMENDMENT. Section 54-10-10 of the North Dakota Century Code is
11	amended and reenacted as follows:
12	54-10-10. Salary of state auditor.
13	The annual salary of the state auditor is eighty-threeninety thousand fivethree hundred
