## 1 A BILL for an Act to provide an appropriation for defraying the expenses of the information

2 technology department; to provide for various transfers; and to amend and reenact section 7 of

3 chapter 49 and section 8 of chapter 519 of the 2009 Session Laws, relating to statewide

4 longitudinal data system expenditures and health information technology.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds 7 as may be necessary, are appropriated out of any moneys in the general fund in the state 8 treasury, not otherwise appropriated, and from special funds derived from federal funds and 9 other income, to the information technology department for the purpose of defraying the 10 expenses of that agency, for the biennium beginning July 1, 2011, and ending June 30, 2013, as

22 2013-15 biennium. The information technology department shall report to the appropriations

23 committees of the sixty-third legislative assembly on the use of this one-time funding for the

biennium beginning July 1, 2011, and ending June 30, 2013.

SECTION 3. TRANSFERS. Notwithstanding section 54-16-04, the director of the office of
management and budget shall make transfers of funds between the salaries and wages,

27 operating expenses, and capital assets line items in section 1 of this Act for the information

technology department as may be requested by the chief information officer as determined

29 necessary for the development and implementation of information projects.

30 SECTION 4. BANK OF NORTH DAKOTA TRANSFER. The industrial commission shall
31 transfer, as requested by the health information technology office director, up to \$5,000,000

1 from the current earnings and accumulated profits of the Bank of North Dakota to the health 2 information technology planning loan fund or to the health information technology loan fund, for 3 the biennium beginning July 1, 2011, and ending June 30, 2013. The health information 4 technology office director shall request transfers from the Bank only as necessary to meet 5 cashflow needs of the fund and only upon certification by the health information technology 6 office director of a demonstrated need for health information technology planning loans. 7 SECTION 5. AMENDMENT. Section 7 of chapter 49 of the 2009 Session Laws is amended 8 and reenacted as follows: 9 **SECTION 7. DEPARTMENT OF PUBLIC INSTRUCTION - STATEWIDE** 10 LONGITUDINAL DATA SYSTEM EXPENDITURES - APPROVAL. The department of 11 public instruction may spend only the federal funds appropriated in House Bill 12 No. 1013 for costs associated with the statewide longitudinal data system upon 13 approval of the expenditures by the information technology department, for the 14 biennium beginning July 1, 20092011, and ending June 30, 20112013. 15 SECTION 6. AMENDMENT. Section 8 of chapter 519 of the 2009 Session Laws is 16 amended and reenacted as follows: 17 SECTION 8. BANK OF NORTH DAKOTA TRANSFERS. The industrial 18 commission shall transfer, during the period beginning with the effective date of this 19 Act and ending June 30, 20112013, as requested by the health information technology 20 office director, up to \$8,000,000 from the current earnings and the accumulated 21 undivided profits of the Bank of North Dakota to the health information technology loan 22 fund to meet any required match for federal funds or to the electronic health 23 information exchange fund to meet any required match for federal funds or for ongoing 24 operating expenditures of the health information exchange or as directed, a portion to 25 both funds to meet any required match for federal funds. The health information-26 technology office director shall request fund transfers from the Bank only as necessary-27 to comply with federal requirements and to meet cash flow needs of the funds.
