### REMARKS OF SENATE MINORITY LEADER RYAN TAYLOR

Mr. President, as we bring to a close this special session of the North Dakota Legislature and complete our work here in the state senate, I want to extend the gratitude of our caucus and myself to all who have helped to organize this session and worked so tirelessly for it to come off so professionally. Thank you to the desk staff, all the employees of the committees and caucus offices, the majority leadership and committee chairs, and all our senate colleagues who pitched in to do the job. Well done.

We knew back in April as the gavel came down on our regular session that we would be back here to pass a plan for redistricting and deal with legislative issues of health care, but it was impossible for us to know what would happen to this state between April and November. Who knew that our state would see flooding along the Mouse River, the Missouri River, and across the state of such epic proportion? Floods that would destroy homes, displace families and ravage communities like we have never seen before. And in western North Dakota, away from the flooding rivers, communities would be flooded with the impacts of rapid and intense oil development that is breaking all historical bounds. We've debated the extent of that help and the mechanisms of delivering it, but, together, both minority and majority, we've contributed ideas and come up with a package that will do good for North Dakota.

While we were here, we couldn't help but be reminded that someone was missing as roll call was taken. As we shared with each other yesterday, we feel the void or our departed colleague. Yet, we all know, this is but one roll call here in this chamber. We will all be subject to another roll call beyond this place, beyond these bounds, and in our work and our lives we are preparing for that roll call. Our time here is precious. We were acutely reminded of that this Veteran's Day with the eloquent remarks of Vietnam veteran Sen. Marcellais.

I am happy today to have my oldest boy here to help cast this morning's roll call votes. As the redistricting plan of this session dictates, it is possible that these could be the last votes I take as a senator, as decisions are made in the future for me and my family. My wife and I have talked about this, and I want to say that if this is my last roll call in this chamber as a senator, as minority leader, I'm at peace with that. We all stand for election and there are no guarantees, and I'm at peace with what may come. I want to say that my time here with all of you has been special, the work we do here has been meaningful, and each of you have my respect as fellow senators.
