1 A BILL for an Act to amend and reenact subsection 2 of section 16.1-01-09 and subsection 2 of
2 section 16.1-01-09.1 of the North Dakota Century Code, relating to the requirements for
3 initiated, referendum, and recall petitions.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Subsection 2 of section 16.1-01-09 of the North Dakota
6 Century Code is amended and reenacted as follows:

7 2. An individual may not sign any initiative or referendum petition circulated pursuant to
8 article III of the Constitution of North Dakota unless the individual is a qualified elector.
9 An individual may not sign any petition more than once, and each signer shall ~~add~~also
10 legibly print the signer's name, complete residential address or rural route or general
11 delivery address, and the date of signing on the petition. Every qualified elector
12 signing a petition shall do so in the presence of the individual circulating the petition. A
13 referendum or initiative petition must be on a form prescribed by the secretary of state
14 containing the following information:

18 We, the undersigned, being qualified electors request [House (Senate) Bill
