- 1 A BILL for an Act to amend and reenact section 39-06.1-06 and subsection 2 of section
- 2 40-05-06 of the North Dakota Century Code, relating to fees for speeding.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 39-06.1-06 of the North Dakota Century Code is
- 5 amended and reenacted as follows:
- 6 **39-06.1-06. Amount of statutory fees.**
- The fees required for a noncriminal disposition pursuant to either section 39-06.1-02 or
- 8 39-06.1-03 must be as follows:
- 9 1. For a nonmoving violation as defined in section 39-06.1-08, a fee of any amount not to exceed twenty dollars.
- 11 2. For a moving violation as defined in section 39-06.1-09, a fee of twenty dollars, except for:
- 13 a. A violation of section 39-10-26, 39-10-26.2, 39-10-41, 39-10-42, 39-10-46, or 39-10-46.1, a fee of fifty dollars.
- b. A violation of section 39-10-05 involving failure to yield to a pedestrian or
 subsection 1 of section 39-10-28, a fee of fifty dollars.
- 17 c. A violation of section 39-21-41.2, a fee of twenty-five dollars.
- d. A violation of subsection 1 of section 39-12-02 or section 39-08-23, a fee of one
 hundred dollars.
- e. A violation of subdivision d of subsection 1 of section 39-12-04, a fee of one hundred dollars.
- f. A violation of subsection 1 of section 39-04-37 by an individual by becoming a resident of this state, a fee of one hundred dollars.

For a violation of any traffic parking regulations, except a violation of subsection 10 of 22 section 39-01-15, on any state charitable or penal institution property or on the state 23 capitol grounds, a fee in the amount of five dollars. 24 7. On a highway on which the speed limit is a speed higher than fifty-five miles [88.51kilometers] an hour, for a violation of section 39-09-02, or an equivalent ordinance, a 25 26 fee established as follows: 27 Miles per hour over 28 Fee lawful speed limit 29 1 - 10 \$2/each mph over limit 30 11+\$20 plus \$5/each mph over 10 mph over limit 31 8. For a violation of section 39-21-41.4, a fee not to exceed twenty dollars.

A violation of subsection 2 of section 39-10-21.1, a fee of two hundred fifty

1 For a violation of section 39-21-44 or a rule adopted under that section, a fee of two 2 hundred fifty dollars. 3 10.9. For a violation of subsection 3 of section 39-21-46, a fee established as follows: 4 Driving more than eleven hours since the last ten hours off duty, driving after 5 fourteen hours on duty since the last ten hours off duty, driving after sixty hours 6 on duty in seven days or seventy hours in eight days, no record of duty status or 7 log book in possession, failing to retain previous seven-day record of duty status 8 or log book, or operating a vehicle with four to six out-of-service defects, one 9 hundred dollars; 10 b. False record of duty status or log book or operating a vehicle with seven to nine 11 out-of-service defects, two hundred fifty dollars; 12 Operating a vehicle after driver placed out of service, operating a vehicle with ten 13 or more out-of-service defects, or operating a vehicle that has been placed out of 14 service prior to its repair, five hundred dollars; and 15 d. All other violations of motor carrier safety rules adopted under subsection 3 of 16 section 39-21-46, fifty dollars. 17 11.10. On a highway on which the speed limit is posted in excess of sixty-five miles [104.61 18 kilometers] an hour, for a violation of section 39-09-02, or equivalent ordinance, a fee 19 of five dollars for each mile per hour over the limit. 20 12.11. For a violation of a school zone speed limit under subdivision b of subsection 1 of 21 section 39-09-02, or, notwithstanding subsection 2 of section 40-05-06 or section 22 40-05.1-06, of an ordinance in a city or home rule city for a violation of a speed limit 23 dependent upon being on or near a school, fees for a noncriminal disposition are 24 fortyeighty dollars for one through ten miles per hour over the posted speed; and 25 fortyeighty dollars, plus one dollartwo dollars for each additional mile per hour over ten 26 miles per hour over the limit unless a greater fee would be applicable under this 27 section. 28 For a violation of a highway construction zone speed limit under subsection 2 of 13.12. 29 section 39-09-02, a fee of eighty dollars for one through ten miles per hour over the 30 posted speed; and eighty dollars plus two dollars for each mile per hour over ten miles

per hour over the limit, unless a greater fee would be applicable under this section.

- The fee in this subsection does not apply to a highway construction zone unless individuals engaged in construction are present at the time and place of the violation and the posted speed limit sign states "Minimum Fee \$80".
- **SECTION 2. AMENDMENT.** Subsection 2 of section 40-05-06 of the North Dakota Century 5 Code is amended and reenacted as follows:
 - 2. <u>a.</u> For Except as otherwise provided under subdivision b, for every violation of a city ordinance regulatingthat regulates the operation or equipment of <u>a</u> motor vehicles vehicle or regulating which regulates traffic, except those ordinances listed in section 39-06.1-05, a fee may be established, by ordinance, which may not exceed the limits, for equivalent categories of violations, set forth in section 39-06.1-06.
 - b. A home rule city may establish, by ordinance, a fee for the violation of a city ordinance that regulates the operation or equipment of a motor vehicle or which regulates traffic, except those ordinances listed in section 39-06.1-05, if the fee is for driving in excess of speed limitations and the fee does not exceed two times the limits in section 39-06.1-06 or if the fee is for a moving violation other than driving in excess of speed limitations and does not exceed three times the limits in section 39-06.1-06.
