- 2 to relocate the Missouri River correctional center; to provide a transfer; to provide for a report to

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

# 5 SECTION 1. APPROPRIATION - DEPARTMENT OF CORRECTIONS AND 6 REHABILITATION - REPORT TO THE LEGISLATIVE MANAGEMENT. There is

6 REHABILITATION - REPORT TO THE LEGISLATIVE MANAGEMENT. There is appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sur

out of any moneys in the general fund in the state treasury, not otherwise appropriated, the sum of \$200,000, or so much of the sum as may be necessary, to the department of corrections and

rehabilitation for the purpose of developing a plan for relocating the Missouri River correctional

center to the youth correctional center site, for the biennium beginning July 1, 2013, and ending

June 30, 2015. The plan must include a determination of facilities, services, and activities that

may be shared by the Missouri River correctional center and the youth correctional center. The

department must present the plan to the legislative management by July 1, 2014.

### 14 SECTION 2. APPROPRIATION - TRANSFER - STATE PENITENTIARY LAND FUND -

15 **LEGISLATIVE INTENT.** There is appropriated out of any moneys in the general fund in the

state treasury, the sum of \$12,000,000, which the office of management and budget shall

transfer on July 1, 2013, to the state penitentiary land fund established in section 54-23.3-04.

18 The funds transferred and interest earned on the moneys transferred must be used for costs of

relocating the Missouri River correctional center. It is the intent of the legislative assembly that If

20 the sixty-fourth legislative assembly does not approve the relocation of the Missouri River

21 correctional center, the funds transferred be returned to the general fund.

### SECTION 3. DEPARTMENT OF CORRECTIONS AND REHABILITATION BUDGET

REQUEST - 2015-17 BIENNIUM. The department of corrections and rehabilitation must include

- 1 in its budget request for the 2015-17 biennium funding provided in section 2 of this Act for the 2 relocation of the Missouri River correctional center.
- 3 SECTION 4. LEGISLATIVE INTENT MISSOURI RIVER CORRECTIONAL CENTER
- 4 LAND REPORTS TO THE LEGISLATIVE MANAGEMENT. It is the intent of the sixty-third
- 5 legislative assembly that once the Missouri River correctional center is relocated to the youth
- 6 correctional center site, all remaining land be transferred to the parks and recreation
- 7 department for recreational purposes and not for residential, business, or industrial purposes.
- 8 The parks and recreation department shall have access to the Missouri River correctional
- 9 center site prior to the transfer of all remaining land and shall develop a ten-year plan for the
- 10 property to be used for recreational purposes. The game and fish department shall work with
- 11 the parks and recreation department to establish a boat landing on the former Missouri River
- 12 correctional center property. The parks and recreation department shall report on the plan and
- progress to implement the plan periodically to a committee designated by the legislative
- 14 management.
